Pension application of William Jaco (Jacko) S36612 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Ohio Sct.

Be it remembered that on the 13th day of July A.D. 1818 of the Independence of the United States the 43rd and of our State the 16 personally appeared before me the subscriber President of the Courts of Common Pleas of the Second Circuit, William Jacko resident of Pike County who after being duly sworn on the Holy Evangelists of Almighty God deposeth and saith that he is in the eighty second year of his age – that he enlisted in the year 1777 for three years in Captain Tripplet's [Thomas Triplett's] Company 16th Virginia Regiment commanded by William Grayson, and served until the termination of the three years in said line on Continental establishment and was in the battles of Germantown [October 4, 1777], Brandywine [September 11, 1777], Monmouth [June 28, 1778], and received his discharge from General Woodford [William Woodford] at Charleston South Carolina which is lost or destroyed by will weigh's unknown to affiant, and he has no evidence in his possession of said service – that from his reduced circumstances he needs the assistance of the Country for support.

[p 10: On May 8, 1820 in Bracken County Kentucky, the veteran, 84, filed another application under the 1818 act making the identical statement set forth above except that he adds that he enlisted in Fairfax County Virginia and that he served until the month of April 1780.]

Kentucky County Court of Bracken in the first Judicial District of Kentucky: SS

On this 1st day of January 1821 personally appeared in open court being a court of record for the County of Bracken in the district aforesaid, William Jaco, aged eighty-four years, who, being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the Acts of Congress of the 18th March 1818 and the 1st May 1820, that he, said William Jaco, enlisted for the term of three years; on, he does not recollect the precise day, but is confident that it was in the month of March in the year 1777 in the State of Virginia, in the company commanded by Captain Thomas Triplett, in the Regiment commanded by Colonel William Grissen or Grayson, in the line of the state of Virginia, on the Continental establishment; that he continued to serve in said Corps until April 1780, when he was discharged from the said service in Charleston in the state of South Carolina. That he was in the battles of Germantown, Brandywine, & Monmouth and that he has no other evidence, now in his power of his said services: and further the said William Jacko solemnly swears that when a resident citizen

of the State of Ohio, on the 18th of July 1818, and in conformity to the aforesaid act of Congress of the 18th March 1818, he, the said William Jacko, did make a statement of his said services to the Department of War, through the medium of Judge John Thompson of Chillicothe Ohio: – And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed: and I do most solemnly swear that I have no property own birth, save a few old close, and the walking stick now in my hand, not worth 4½ C,, I have no income whatever either public or private, I have no family, nor have I any occupation: I live with my son-in-law on whom I am dependent.

[Veteran was pensioned at the rate of \$8 per month commencing July 13, 1818, for service as a private for 3 years in the Virginia Continental line.]
