Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

County of Chatham, District of Georgia

On this nineteenth day of April in the year 1819, before me the Subscriber one of the Justices of the Inferior Court for the County of Chatham, in said district personally appeared David Ambrose, aged about 60 years, resident at Tuccassee King [Tuckasee King]¹, in the County of Effingham in said district, who being by me first duly sworn, according to law, doth on his oath make the following declaration, in order to obtain the provision made by the late act of Congress entitled "An act to provide for certain persons engaged in the land & naval service of the United States in the revolutionary war." That he the said David Ambrose enlisted for the term of nine months on the second day of May in the year 1775, near Newbern [New Bern] in the State of North Carolina in the company commanded by Captain Fenner [William Fenner] (whose Christian name he does not remember) of the Regiment commanded by Colonel Martin [Alexander Martin] (whose Christian name he does not know) in the line of the State of North Carolina, on the Continental establishment, that he continued to serve in the said corps, or in the Service of the United States until sometime in the months of January or February in the year 1776, when he reenlisted in the same company (which was then without a Captain) of the Regiment commanded by Colonel Martin, in the line of the State of North Carolina, on the Continental establishment, for three years, that Captain Tait [Joseph Tate] afterwards took command of said company & died a short time after, & the company was afterwards commanded by Captain Armstrong [Thomas Armstrong] that he does not remember under whose command he said company was at the time of his reenlistment, that he continued to serve in the said work, or in the Service of the United States, until the end of the war and was some time, after (the precise time he cannot recollect) discharged from service until further orders, in Wilmington, in the State of North Carolina; that he was in the Battles of Brandywine [September 11, 1777], Germantown [October 4, 1777], Monmouth [June 28, 1778] & Eutaw Springs [September 8, 1781]; and that he is in reduced circumstances and stands in need of the assistance of his Country for support, and that he has no other evidence now in his power of his said services. That during the time he served as aforesaid he served as a drummer. Sworn to before me the 19th of July 1819.

[Musician] in Captain Allen's Company of the 2nd Regiment was mustered in the year 1777 for the war, that he was a private in April 1778, and a Mus. In 1781.
