[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Georgia Jackson County} In the Superior Court of said County, September Term 1820

On this twenty seventh day of September 1820, personally appeared in open court (being a court of Record according to the Constitution & Laws of this State) John Black, age sixty-one years, who being first duly sworn according to law, doth, on his oath make the following declaration in order to obtain the provision made by the act of Congress of the 18th March 1818 and the 1st of May 1820. That he the said John Black enlisted for the term of three years in or about the month of July in the year 1777 in the State of South Carolina in the company commanded by Captain Risbo [sic, probably Henry Richbourg] afterwards commanded by Captain James Hathorne [sic, James Hawthorne], & afterwards by Captain Henry Hampton, in the sixth Regiment commanded by Colonel Thomas Sumpter [sic, Thomas Sumter] & afterwards by Colonel William Henderson in the line of the State of South Carolina on Continental establishment. That he continued to serve in said corps for three years until the summer of the year 1780 when he was discharged from the said service, being at the time of his discharge a recruiting Sergeant in the upper part of South Carolina with his Captain Henry Hampton, by whom his discharge was signed & which discharge was transmitted by mail to the War department in March last with an application then made by him for a pension under the act of 18th March 1818 since which time he has never heard of his application or discharge. The declarant saith he afterwards entered the State service in Colonel Maham's [Hezekiah Maham's] Regiment of horse & served in that during the war. That while in Continental service he was in the battle at Stono [June 20, 1779], & was under General Lincoln [Benjamin Lincoln] when he came on the back of the British when they first came down upon Charleston from thence into Stono where the battle was.

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. The declarant further saith that he is by occupation a farmer or planter, that he hath residing with him a wife aged 58 years, & two children wanted a son named William G. Black aged 17 years

& a daughter named Jane aged 13. They are both healthy but the boy is a cripple from his youth. That this deponent owns no land or other property than is contained in the schedule hereto annexed viz.

1 lame & old horse

2 Cows & three yearlings & one calf

1 sow & 10 days

1 shovel plough 1 axe, 1 iron wedge, 1 pair trace chains 2 beds & furniture, 1 table, & small portion of crockery & other wares 1 pot 1 oven 1 skillet, & about three dollars in debts due to me. He concurs [?] all he is worth not to exceed one hundred dollars.

Georgia Hall County} Personally came in open Court, being a Court of Record according to the laws and Constitution of this State, John Hamilton, and Christian Willson, and on their oaths, depose and say, that John Black Applicant, did of their own knowledge, enlist and serve nine months or more in the sixth Regiment of the South Carolina line on Continental Establishment, commanded by Colonel Thomas Sumter.

Black is a cripple from his infancy that this deponent owns no land or other property than is contained in the schedule hereto annexed and subscribed by this deponent -- to wit

- 1 set knives & forks

the above Schedule applicant saith includes every article of value by him on or property necessary bedding and clothing excepted
