Pension application of James Buchanan S37812 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Georgia Newton County

On the thirtieth day of September in the year 1829 personally appeared in open Court being a Court of record in & for the [illegible] Circuit said County & State James Buchanan resident in said County aged 69 years who first being duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by act of Congress for the 18th March 1818 and the 1st May 1820; that he the said James Buchanan enlisted for the term of three years in the fall of the year 1778 according to the best of his recollection in the State of South Carolina in the Company commanded by John Buchanan at the time of his enlistment in the Regiment commanded by Colonel Sumpter [sic, Thomas Sumter] subsequently transferred to the Regiment commanded by Colonel Pinckney [Charles Cotesworth Pinckney] and Captain Jackson's [William Jackson's] Company in the Continental establishment; that he continued to serve in the said Corps until the 12th day of May 1780 when he was among the number of the prisoners taken by the British at the fall of Charleston¹ and that he made his escape from his said imprisonment and joined the Militia of the State of South Carolina and continued in service until the restoration of peace; that he hereby relinquishes every claim whatever to a pension except the present, that his name is not upon the roll of any State and that the following are the reasons for not making earlier application for a pension that he is a man who pursues the humble walks of life, that he has always resided at a considerable distance from the Court House, that there are but few newspapers taken in his neighborhood and that he did not know with certainty until the last winter that any provision was made for indigent Revolutionary Soldiers -- Had he had known that such provision was made he would have [indecipherable word] by his circumstances to have made the application long since. And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war"

passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. Since the act of the 18th Marched 1818 no changes have taken place in his property that has affected his pecuniary matters except the loss of two horses by death, that he has always been indeed a poor man since he came from the service of his Country -- and making [several indecipherable words] support by the labor of his own hands until age has crept upon him & rendered it necessary for him to make the present demand from the government. He is by occupation a farmer with but little ability to pursue it being occasionally afflicted with pains in both his shoulders. He has in family himself and aged wife & daughter.
