[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

### Virginia Isle of Wight County to wit:

On this tenth day of May in the year 1819 before me the subscriber one of the Judges of the General Court of Virginia, personally appeared John Hargrove aged between sixty and seventy years resident in the County of Surry in the State of Virginia, who being by me first duly sworn according to law, doth on his oath make the following declaration, in order to obtain the provision made by the late act of Congress entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" That he the said John Hargrove enlisted in the town of Murfreesborough in the County of Hertford in the State of North Carolina in the 2nd North Carolina Continental Battalion commanded by Colonel John Patten sometime in the year 1777, that he continued to serve in the Army until the 30th of June in the year 1780 when he was discharged at Murfreesborough aforesaid. That he was in the battle at Monmouth at the siege of Charleston in South Carolina and in various skirmishes during the time of service. That he is in reduced circumstances and stands in need of the assistance of his country for support and that he hath no other evidence now in his possession of his said services except his discharge herewith sent in the annexed affidavits.

## Virginia Isle of Wight County to wit

George Bevan and Thomas Clary personally appeared before me one of the Judges of the General Court of Virginia on this 10th day of May 1819 and being first sworn states that they were well acquainted with John Hargrove and his circumstances, and knew that he did enlist as a soldier in the Army during the war of the revolution and that he is in reduced circumstances and requires assistance to enable him to support himself.

On the twenty third day of October 1820 personally appeared in Open Court, being a Court of Record for the County of Surry aforesaid in the State of Virginia John Hargrave aged sixty-six years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provisions made by the acts of Congress of the 18th of March 1818 and the 1st May 1820 that he the said John Hargrave enlisted for the term of 3 years on the \_\_\_ day of May in the year 1778 in the State of North Carolina in the Company commanded by Major Hardy Murfree in the Regiment commanded by Colonel Patern [Patton or Patten] in the line of the State of North Carolina on the American Continental establishment that he continued

to serve in said Corps until the \_\_ day of June 1781 when he was discharged from said service at Murpheys Borough [Murfreesborough] in the State of North Carolina. That he was in the battle of Monmouth and that he has no other evidence now in his power of his said service except his discharge and affidavits of Thomas Clary and George Bevan forwarded to the War Department of the United States,

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed S/ John Hargrave<sup>1</sup>

Schedule of the property Real and Personal (except necessary clothing, Beds and bedding) of John Hargrave of the County of Surry and Late a private in the Army of the Revolution Eighty acres of land, one horse, four cows, two heifers, one calf, eight hogs, Sow and five shoats, two chests, six rush bottomed chairs, two square pine tables, one large pot, two small ditto, one Dutch oven, 19 Cyder Barrels, Skillet, one flute hoe, two trowel hoes, two weeding hoes, three axes, cart wheels, three pewter dishes, 6 pewter plates, 7 spoons, 5 knives, 6 ports, spinning wheel, one man's saddle, one side Saddle, 3 Earthen bowls, to jugs, for case bottles, one loom, two Slays, one [indecipherable word, starts with "H"] some Cups and Saucers & old Gun.
