[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." District of Virginia to wit Northumberland County Court February 8<sup>th</sup> 1819

On this 8<sup>th</sup> day of February 1819 John Haydon aged 62 years & upwards appeared in open Court within the District aforesaid and being duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "an act to provide for certain persons engaged in the Land & Naval service of the United States in the Revolutionary War." That he the said John Haydon entered the Army of the Revolution for the term of one year on the 17<sup>th</sup> day of February 1778 at Valley Forge in the State of Pennsylvania in the company commanded by Captain Colston [Samuel Colston] of the 5<sup>th</sup> Virginia Regiment on Continental establishment, the said Regiment was commanded by Colonel Burgess Ball & that he continued to serve in the said Corps, or in the service of the United States, until the 17<sup>th</sup> day of February 1779 when he was discharged from service at Middlebrook in the State of New Jersey, and that he is in reduced circumstances and stands in need of the assistance of his Country for support & that he has no other evidence now in his power of his said service.

This is [to] Certify that John Haydon in Northumberland County & State of Virginia served in Samuel Colson's [sic] Company of Infantry in the Service of the United States from the 17<sup>th</sup> day of February 1778 until the 17<sup>th</sup> day of February 1779 & was discharged at Middlebrook in the State of New Jersey.
