### Pension application of Joshua Hundley S38063 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

#### Virginia

At a Court held for the County of Amelia before the justices of the peace for said County on Thursday the 22<sup>nd</sup> day of October 1818 and forty third year of the Commonwealth,

Joshua Hundley this day personally appeared in Court and being first duly sworn according to law doth make the following declaration in order to obtain the provision made by the late act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War." That the said Joshua Hundley enlisted in the County of Amelia in the State of Virginia in the company commanded by Captain James Foster of the 15<sup>th</sup> Virginia Regiment in January 1777. That he continued to serve in the said Corps or in the service of the United States until the \_\_ day of \_\_ 1780 when he was discharged from service in Philadelphia State of Pennsylvania, that he was in the battles of German Town [Germantown, October 4, 1777], Monmouth [June 28, 1778], and Stony Point [July 16, 1779], and that he is in reduced circumstances and stands in need of the assistance of his country for support and that he has no other evidence now in his power of his said services (except the certificate of Daniel Verser now exhibited). That he is now fifty-nine years of age and is a resident of said County of Amelia.


Anderson Tucker being first duly sworn in open Court saith that Joshua Hundley is in reduced circumstances. All of which is ordered to be certified to the Secretary of War.

Virginia Amelia County Court Clerk's Office, I John T Leigh clerk of the County Court aforesaid do hereby certify that the foregoing is a true Copy of the declaration &c made by Joshua Hunley in open Court and entered in record. In Testimony whereof I have hereunto set my hand and seal of said County this 6<sup>th</sup> day of November 1818

I do certify that Joshua Hundley was a soldier in the 15<sup>th</sup> Virginia Regiment in the revolutionary war, in Captain James Foster's Company and remained in the service three years (in the service), he was in the same Platoon with myself at Germantown the 4<sup>th</sup> day of October 1777 and received a wound at the same time, he was a good Soldier during his three years service.

Nottoway County to wit

This day Daniel Verser made oath before me Archer Roberts one of the Justices of the peace for the County aforesaid that Joshua Hundley was enlisted by Captain James Foster of Amelia County for 3 years in the Revolutionary war and was wounded through the left ankle in the battle German town the 4<sup>th</sup> of October 1777 he was commanded by Colonel Ennis [James Innis], that Campaign, and many other Colonels during his three years service he belonged to the 15<sup>th</sup> Virginia Regiment in 1777 after that the companies was so drafted into other regiments it is not possible for me to recollect all the Colonels he was commanded by during his term of service, he was a brave soldier, I was with him in many hard fought battles to the North.

### Virginia Amelia County to wit

On this 26 day of October 1820 personally appeared in Open Court before the Justices of the peace for the County aforesaid being a court of record Joshua Hundley aged about sixty-two years resident in said County of Amelia who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary war as follows viz. that he entered the service about February 1777 for the term of three years in company commanded by Captain James Foster in the Regiment commanded by Colonel Enis [James Innis] in the line of the State of Virginia on Continental establishment, that he continued to serve in said Corps until February 1780 when he was discharged from said service in the state of Pennsylvania at Philadelphia that he was in the battles of German Town, Brandy-wine [Brandywine, September 11, 1777], Monmouth Courthouse, and Stony Point.

That he has heretofore received a pension under a pension certificate Number 12581 issued on the original declaration dated \_\_\_. And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed Schedule
