[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Virginia – Madison County to wit

On the 15th day of May 1818 personally appeared before no [sic] the Commonwealths Justices of the peace in sitting as a Court in and for the County aforesaid James Jackson aged fifty-seven years resident in the County and State aforesaid, who being first duly sworn, according to law, doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress "entitled an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" that the said James Jackson enlisted in the month of March 1776 in the state of Virginia in the company commanded by Francis Taylor in the second Virginia Regiment commanded by Alexander Spotswood on Continental establishment and continued in service twenty-four months that he was honorably discharged from service in the State of Pennsylvania – that he was in the battles of Amboy [March 8, 1777, also called the battle of Punk Hill] & others

That he is in reduced circumstances and stands in need of the assistance of his Country for support & that he has no other evidence.

Madison County to wit

This Day Joseph Thomas¹ came before me a justice of the peace for said County and made oath that Jeames Jacson [sic sic] Senr. of said County served in Captain Francis Taylor's Company in the Regular Service two years as a Soldier in the Second Virginia Regiment in the year Seventysix and Seventy-seven and in 78 he went and joined the horse Company and fester [sic, further?] he knew not. Given under my hand this 16 day of June 1819

I do Certify that James Jackson enlisted himself a soldier in Captain Francis Taylor's Company of the 2nd Virginia Regiment on Continental establishment and spring of the year 1776 and continued in service for the term of 2 years.

State of Virginia Madison County to wit

On this 28th day of August 1832 personally appeared in open Court being a Court of Record for the said County according to the laws of Virginia, James Jackson resident in the said County aged 63 years, who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the acts of Congress of the 18th of March 1818 and the first May 1820, that he the said James Jackson enlisted during the War of the Revolution on the 21st day of March in the year 1781 in the State of Virginia previous to which time he had served 2 years as a riflemen on Continental establishment in the company commanded by Captain Baylor Hill in the first Regiment of the light Dragoons commanded by Colonel Anthony W White in the line of the State of Virginia on the Continental establishment; that he continued to serve in the said Corps until the 10th day of October 1783, when he was discharged from the said service on the Santee River in the State of South Carolina that his name has been placed on the pension list and dropped there from on account of his property. And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed 8 Schedule of said James Jackson's property

The declarant is a mill right [millwright] by occupation, but is very infirm. His family consist of his wife 57 years old and infirm: 4 daughters named Betsey aged 33 years, weaves, spins &c, Polly aged 21 years, same occupation, Patsey 19 years old same occupation, – Tabitha aged 15 years, same occupation. 2 sons, Joseph aged 19 years, by occupation farmer, Humphrey aged 14 years same occupation.

The declarant has sold no property since his former declaration that the following changes have taken place
