Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Georgia Wilkes County: Wilkes Superior Court February Term 1819

Came into open court Abraham P. Jones who being sworn saith that he entered the service of the United States on the sixth day of September in the year of our Lord 1776 as a brevet Ensign in the second Georgia Continental Regiment commanded at that time by Colonel Samuel Elbert and in Captain Francis Moore's company, that he remained in said Regiment about three years, during which time he was promoted by brevet to 2nd Lieutenant.

And this deponent also states that he procured a regular discharge from Colonel Samuel Elbert, which discharge together with his Brevet Commissions and other military papers was taken from him at or near Ludwell's old Mills¹ in the State of Virginia by the light horse troops commanded by Colonel Tarleton [Banastre Tarleton] and this deponent also states that there is none of his fellow soldiers who lived near him by whom he can establish the foregoing facts. And he also further states that he is now old & infirm and unfortunately reduced to the most necessitous circumstances that he is unable to support or maintain himself without application to his country for assistance.

three years, and that the said Abraham P. Jones was also a Lieutenant in the said Regiment before he left that service.

Personally appeared in open court Abraham P. Jones of the State and County aforesaid who being duly sworn deposeth and saith that he entered into the Service of the United States on the 6th day of September in the year of our Lord 1776 as a brevet Ensign in the Second Georgia Continental Regiment commanded at that time by Colonel Samuel Elbert and in Captain Francis Moore's company that he remained in said Regiment about three years during which time he was promoted by brevet to Second Lieutenant and this deponent further states that he procured a regular discharge from Colonel Samuel Elbert which discharge together with his brevet commissions and other military papers was taken from him at or near Ludwell's old Mills in the State of Virginia by the light horse troops commanded by Colonel Tarleton and this deponent also further states that he is now old and infirm and reduced to search circumstances that he requires assistance from his Country -- And that the above mentioned service was performed in said Regiment upon the Continental establishment in the revolutionary war. On this 22nd day of August 1820 personally appeared in open court being a Court of record for said district & the Supr [Superior] Court for the County of Putnam in Georgia Abraham P. Jones aged sixty-eight years resident in the County of Putnam and said district who being first duly sworn according to law doth on his oath declare that he served in the revolutionary war as follows viz. as a second Lieutenant in the company commanded by Captain Francis Moore in the Second Regiment of the Georgia Continental line (the original certificate believed to be dated on the 16th of February 1819 for a pension Certificate No. 16-889). And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed.

The following is Schedule of my real and personal Estate necessary clothing and bedding excepted viz. 123 1/2 acres of land in the County of Putnam & State of Georgia, 2 horses, 5 head of Horn Cattle, 20 head of hogs & pigs & debt due to me of \$358. I owe rather more than \$1136.07 ½. I am a farmer I am infirm and entire[ly] cripple in the right shoulder so as to be unable to work, my family consists of my wife & a son and a daughter, my wife Ann Jones is fifty-eight years old has been subject to fits for ten years is bed ridden about two thirds of her time and is unable to work, my son William Jones is 18 years old and has no property my daughter Susan Jones is 15 years old & has no property.

[pp 45-47: On September 19, 1821, the veteran filed yet another application, this one substantially identical to the one he filed August 22, 1820, except this time he only lists his wife (of which he says she is subject to "hard convulsive fits, pains (supposed to be rheumatics) & the colic She is confined to her bed about two thirds of that her time and is almost entirely helpless") as being part of his family and his property is reduced to the following:

For the purpose of obtaining the benefits of an act entitled "An act for the relief of certain surviving officers and soldiers of the Army of the Revolution," approved on the 15th of May, 1828, I Abraham P. Jones, of the County of Columbia, in the State of Georgia, do hereby declare that I was an officer in the Continental Line of the Army of the Revolution, and served as such, to the time when the arrangement of the Army provided by the resolves of Congress of the 3rd and 21st of October, 1780, was carried into effect, and was reduced under that arrangement, at which period I was a second Lieutenant in the second Regiment of the Georgia line.

And I also declare, that I afterwards received a certificate (commonly called a commutation certificate) for a sum equal to the amount of 5 years full pay, which sum was offered by the resolve of Congress, of the 22nd of March 1783, instead of the half pay for life, to which I was entitled under the resolve of the 21st of October 1780.

And I do further declare, that I have received of the United States, as a pensioner, since the 3rd day of March 1826, the sum of \$480, paid to me by the Agent for paying pensions in the State of Georgia, up to the 3rd of March 1828, and since that period I have received no money, as a Pensioner of the United States.

Before me B. Pettit, JP in the County of Columbia, in the State of Georgia personally appeared this day Abraham P. Jones, the person by whom the foregoing declaration was subscribed, who did make oath that his Commission as an Officer as stated in his said declaration was taken from him by the British when he was taken prisoner by Tarleton's Troop of Horse, near Ludwell's Mills in Virginia, and that he was exchanged soon after the provisional articles of

peace were agreed upon, and continued in the Army until the Treaty of Peace: -- And that for further evidence he refers to certain depositions and other testimony of file in the War Department, on which he the said Abraham P. Jones was placed on the Pension Roll of the United States -- witness my hand this 12th of July 1828
