## Pension application of George Johnston S38088 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later intereenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

District and State of Virginia, Jefferson County Sct.

On this 21<sup>st</sup> day of April 1818 before me the subscriber presiding and sole judge of the superior Court of Law for the said County of Jefferson in the 9<sup>th</sup> District and State aforesaid personally appeared George Johnston aged 78 years and resident in the said County and district, who being first duly sworn by me according to law doth on his oath make the following declaration in order to obtain the provisions made for certain persons engaged in the land and naval service of the United States in the revolutionary war. That he the said George Johnston enlisted in February 1776 at Martinsburg in the State aforesaid in the company commanded by Captain George Wayles [probably George Walls] in the 4<sup>th</sup> Virginia Regiment commanded by Colonel John Nevill [John Neville] and was afterwards transferred to Captain Griffin Stith's company by whom his discharge was signed. That he continued to serve in the said Corps or in the service of the United States until the full expiration of his term of service which was three years when he was discharged from service at Middlebrook New Jersey. That he was in the battle of Germantown [October 4, 1777] & Monmouth [June 28, 1778]. That he is in reduced circumstances and stands in need of the assistance of his country for support and that he has no other evidence now in his power of his said services except the testimony under oath of Abram Davenport who has sworn that he said Davenport did carry to Richmond and delivered to General Wood one of the Council of State said George Johnston's discharge from service. On this 24<sup>th</sup> day of July 1820, personally appeared in open Court being a Court of record for the said County George Johnston aged eighty years, resident in said County, who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary war as follows that he enlisted at Martinsburg Berkeley County State of Virginia in the year 1776 and

served 3 years (as will appear by the documents filed with my declaration for a pension about the fall of 1818) and was in the Battle of German Town and Monmouth and Trenton [December 26, 1776] and at the taking of Cornwallis [October 19, 1781] – and I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed and that I am unable to maintain and support myself by labor and that I have no possession, but have hitherto supported myself by day labor and have no family residing with me and have received a pension by virtue of a certificate No. 4.120.

I have no property except some wearing apparel and some in different articles of household furniture and seven small hogs.

Sworn to and declared on the 14<sup>th</sup> day of July 1820 in open Court S/ George Johnson, X his mark

[the court valued the veterans property as being worth \$14]

This day personally appeared before me the undersigned one of the Justices of the peace in and for the County of Jefferson, John Cross, <sup>1</sup> and made oath that George Johnson [sic] enlisted under Captain Fitchpatrick (or Killpatrick) in the year 1781 in then Berkeley now Jefferson County, to serve during the war, and that the said George Johnson served with him the said John Cross in the company commanded by the said Fitchpatrick (or Killpatrick) which company was attached to the 8<sup>th</sup> Virginia Regiment and was ordered to join General Green [Nathanael Greene] in the South, but on the way the company to which he belonged was countermanded and ordered to join the Army in pursuit of Lord Cornwallis, and that it became attached to the Army at York, and was commanded by Colonel Gaskins & Major Willis, before the arrival of General Washington – and that the affiant joined the Course afterwards and knows nothing of the said Johnson after that time until the conclusion of the war.

[Veteran was pensioned at the rate of \$8 per month commencing April 21, 1818, for service as a private in the Virginia Continental line.]

I do hereby Certify that I had in my possession George Johnston's Discharge as a soldier in the revolution war to get his land warrant in Richmond and left it with General James Wood who was Lieutenant Governor That time at the death of Wood his discharge got lost or mislaid & this
