[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Virginia Chesterfield County: June the 8th 1818

On this 8th day of June 1818 before the Justices of the aforesaid County in court sitting personally appeared Richard Jones aged 80 years resident in the County of Chesterfield who being by me first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "An act to provide for certain persons engaged in the Land & naval service of the United States in the revolutionary war" that he the said Richard Jones enlisted in the state of North Carolina in the company commanded by Captain James Gun of the first Regiment of Light dragoons that he continued to serve in said Corps, or in the service of the United States until the close of the War when he was discharged from the service in the County of Henrico & State of Virginia after having served about three years, that he was in the battles of Camden, __ & he is in reduced circumstances & stands in need of the assistance of his country for support & that he has no other evidence now in his power of his said services.

Sworn to & declared before me the day & year aforesaid.

To this declaration is also added the certificate of William Hise which is hereto annexed S/ Edmd Lockett

Chesterfield County to wit

This day William Hise [could be William Hix]¹ of the aforesaid County made oath before Edmund Lockett now presiding Judge of the Chesterfield court now sitting that a few years after the close of the Revolutionary War he saw the discharge of Richard Jones who had been for several years in the service of his country against the common enemy; that he saw two of the land warrants then in the name of & owned by the said Richard Jones, that he the said William Hise sold one of the aforesaid land warrants for the benefit of the said Richard Jones – paid over the amount of the money received for the said warrant to the said Richard Jones.

On this 16th day of August 1820 personally appeared in open court, being a court of

record for said County by an act of the General Assembly of Virginia establishing County courts; Richard Jones upwards of 80 years of age, resident in said County of Chesterfield, who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary war on the Continental establishment in the Virginia line in the southern Army, that he enlisted in a company commanded by Captain Gun of the light Dragoons in the year 1781 and was attached to the Regiment of Colonel Wight (or White) [perhaps Anthony Walton White] as will appear by my declaration made in said County on the 8th day of June in the year 1818 & my pension certificate heretofore granted is numbered 5313 & I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

Schedule

One feather bed value \$20: 4 chairs value \$4: one iron pot \$1.50: one skillet \$.25; and a life estate in 70 acres of very poor land, not worth more than 24/ per acre in fee simple. I the said Richard Jones and by occupation a farmer or planter, my age and infirmities, however now prevent me from laboring in any way, cannot walk across a house without my crutches, I have no family of any kind and am entirely depended upon a married daughter for the few comforts of life which I enjoy, but as she is entirely without my control, these small services which are occasionally rendered to me, may be withdrawn whenever of my said daughter may choose

State of Virginia Chesterfield County to wit

On this 9th day of July 1821 personally appeared in open court being a court of record for said County by an act of the General Assembly establishing County courts, Richard Jones and by way of amendment to the declaration and schedule heretofore made by him made oath that he is a farmer by occupation, but that he is personally unable to do any manner of service, and is unable even to walk except upon crutches, that his stepdaughter named Martha Watkins aged about 40 years lives with him and that she has a son named William F Watkins aged about 6 years, – a daughter named Mary Watkins aged about 4 years, a son Thomas Watkins aged about 3 years and an infant child about 5 months old.
