## Pension application of Peter Mason S38172 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## Original Claim

Declaration, in order to be placed on the pension list, under the act of the 18th March, 1818 County of Lunenburg State of Virginia, to wit, on this 9th Day of May 1825, personally appeared in open court, (being a Court of record for the County of Lunenburg aforesaid) Peter Mason resident in said County aged sixty-eight years, who, being first duly sworn, according to law, doth, on his oath, make the following declaration, in order to obtain the provision made by the acts of Congress, of the 18th March 1818, and the 1st May 1820: that he, the said Peter Mason enlisted for the term of 12 months on the \_\_ day of \_\_ in the year 1776, in the State of Virginia, Prince Edward County, in the company commanded by Captain George Handley in the Regiment commanded by Colonel Jos. Harbarham [sic, Joseph Habersham] in the line of the State of Georgia on the Continental establishment; that he continued to serve in said Corps until the 6th the summer 1777 when he was discharged from the service, in Savannah in the State of Georgia that he hereby relinquishes every claim whatever to a pension, except the present; that his name is not on the roll of any State; and that the following all the reasons for not making earlier application for a pension: that he held an estate for the life of his wife, who has died in the last 12 months whereby he is entirely deprived of that resource – And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. That, since the 18th of March 1818, the following changes have been made in my property that as above said, I have lost the Estate for the life of my wife, which I then held -- & that all the property I now have it is the clothes I wear. Sworn to, and declared, on the 9th day of May 1825 in presence of the Court

[Veteran was pensioned at the rate of \$8 per month commencing May 9, 1825, for service as a private for one year in the Georgia Continental line.]
