Pension application of James McIlheny (McIlhany, McIlhaney) S38188 f16VA Transcribed by Will Graves 5/2/13

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

I James McIlheny of Huntsville in the Alabama territory deposeth that I served as a private in the 12<sup>th</sup> Virginia Regiment of the Continental Establishment under Colonel Gresham, Captain Lapsley and Lieutenant Brackenridge from the month of March in the 3<sup>rd</sup> year of the Revolutionary War until the Regiment was broken up and joined to the 16<sup>th</sup>. I afterwards served in the 16<sup>th</sup> Regiment of Virginia on the Continental establishment until the year 1781 being three years in the whole – When the British Army went off to the southward, myself and some others whose time of service was nearly at and in was left behind, I was shortly after sent under a Captain Phillips from Philadelphia to little York escorting prisoners to that place, then after I arrived there I received my discharge from him about the first of March in the 6<sup>th</sup> year of the War, as well as I can recollect it was the year 1781, I was at the battle of Monmouth [June 28, 1778], at the taking of Stoney Point [Stony Point July 16, 1779] and Powles Hook [Paulus Hook, August 19, 1779] and have been in several other skirmishes at different places – I am at present unable to support myself either by manual labor, yearly income or any property whatsoever, I am now in the sixty fifth year of my age in enfeebled in body, mind and memory, I make this my application for the benefit of the Act of Congress giving relief to persons in my

Witness my hand Huntsville October 9<sup>th</sup> 1818

In addition to the above I received an Honorable discharge which I sent to Richmond by my brother to obtain a land warrant, where I believe it remains in the proper office.

State of Alabama, Superior Court of Madison County October Term 1819

This 6<sup>th</sup> day of October 1819 came James McIlhaney before said court & made oath That he cannot now see to read or write. That in his application made before the Honorable Obadiah Jones Esquire on the 8<sup>th</sup> day of October 1818 – the name of the Colonel under whom he served was by mistake stated as he has been informed & believes to be Grisham. This affiant says that he served as a private in the 12<sup>th</sup> Virginia Regiment on the Continental establishment under the command of Colonel Grayson (as well as he recollects, Colonel William Grayson) and in the 16<sup>th</sup> Virginia Regiment on Continental establishment as stated in his aforesaid application before

judge Jones, being in the whole 3 years on the Continental establishment.


[Veteran was pensioned at the rate of \$8 per month commencing October 8, 1818, for service as a private in the Virginia Continental line.]

These are to Certify that James McIlhaney formerly a soldier in the 16<sup>th</sup> Virginia Regiment has duly and faithfully served the term of three years full which he was enlisted and in consequence of and at his request he is hereby Discharged from further service in the Army of the United States and permitted to return to his home free and [indecipherable word] he having received all his Bounty Pay and Clothing and Deficiencies of pay & Clothing in full of all allowances and provision made by Congress to their troops his receipt for which is on the back hereof Given under my hand at Philadelphia 17 February 1780.
