Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." I John Nash of Northumberland County Virginia to declare that in the year 1780 I joined the second Virginia Detachment upon Continental establishment, that I served during the term of eighteen months in the southern Army under the command of General Green [sic, Nathanael Greene] – that I was at first under the command of Colonel Hawes [Samuel Hawes] until he was taken sick at Ninety Six and was then under Colonel Campbell [Lt. Col. Richard Campbell] until he was killed in the battle of Eutaw Springs [September 8, 1781], and was then honorably discharged at Salisbury in North Carolina on the 17th day January 1782 as per discharge accompanying this declaration signed by Major Snead [Smith Snead] & Lieutenant Hackley [John Hackley] and do moreover declare that from my present reduced circumstances, I am in need of the assistance of my Country for support.

District of Virginia, Northumberland County, to wit

On this __ day of May 1821 personally appeared in open court being a court of record expressly made so by the laws of this Commonwealth, by which the same was created John Nash aged sixty years resident in the County of Northumberland in the said district who being first duly sworn according to law doth on his oath declare that he served in the revolutionary war as follows, to wit: -that in the year 1780 he joined the second Virginia Regiment upon Continental establishment commanded first by Colonel Hawes and afterwards by Colonel Campbell, that he served during the term of 18 months in the Southern Army under the command of General Greene and was honorably discharged at Salisbury in North Carolina on the 17th day of July [sic] 1782 – that his original declaration bears date the 8th day of February 1819 and his pension certificate is numbered 11303 – and I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or otherwise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

His family residing with him to wit, Fanny his wife aged 31 years, right arm injured by a fall from a horse, allows tolerably well, William his son aged 27 years diseased from infancy, legs contracted, one arm broken-- diminutive size & entirely unable to get his livelihood by his labor.
