[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

District of West Tennessee

Richard Dean a Citizen of Rutherford County in said district came before me and claimed to be placed on the pension list of the United States in consequence of his services as a soldier or in the revolutionary war, and after being duly sworn deposeth and saith that the command of Captain John Baker in the North Carolina Continental line in the 3rd Regiment Commanded by Colonel Hogan [James Hogun] that he enlisted for nine months and that he served the said nine months and 13 days faithfully and received his discharge at Halifax in North Carolina, that he enlisted on the 20th day of July 1778. That he never took any care of his discharge, that it is lost or mislaid. That he is 62 years old and very poor and in reduced circumstances insomuch so that he stands much in need of aid from Government. That he never had any pension from the United States, or any State.

State of North Carolina Secretary's Office 11th November 1819

I William Hill Secretary of State in & for the State aforesaid do hereby certify that it appears from the muster roll of the North Carolina Continental line in the Revolutionary War that Richard Dean a private in Captain Baker's Company of the 10th Regiment was mustered on the 20th of July 1778 for nine months. Nothing is said about his discharge, it is therefore reasonable to suppose he served the time for which he enlisted.

District of West Tennessee

On this 22nd day of September 1820, personally appeared in open court, the same being the court of pleas & quarter Sessions of the County of Rutherford & State aforesaid & also the same being a Court of Record, Richard Dean aged sixty-three years, resident in said County of Rutherford, who being first duly sworn according to law, doth on his oath declare, that he served in the revolutionary war as follows – That he enlisted in Captain Baker's Company of the third Regiment, commanded by Colonel James Hogan [James Hogun], of the North Carolina on the Continental establishment & served as a common soldier in said company for the space of nine months & 13 days when he was discharged. He made an original declaration on the 14th day of August 1818, before John McNairy, upon which he obtained a pension certificate No. 16215, dated the fourth day of December 1819, by which he became entitled to draw his pension at the rate of eight dollars per month commencing on the 14th day of August 1818. And I do solemnly swear that I was a resident Citizen of the United States on the 18th of March 1818 and that I have not since that time by gift, sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of An Act of Congress entitled "An Act to provide for certain persons engaged in the land and naval Service of the United States in the Revolutionary War," passed on the 18th day of March 1818; and that I have not, nor has any person in trust for me, any property or securities, contracts or debts due to me, nor have I any income other than what is contained in the Schedule hereto annexed and by me Subscribed:

His occupation is that of a mill stone cutter & from his age, & bodily as well as mental infirmities & the weakness & failure of his eyes, he is not able to pursue it so successfully as to ensure a necessary maintenance – he has no family residing with him & he is without a home.

Sworn to & declared on the 22nd day of September 1820 in open Court.
