William Foster now a citizen of the county of Davidson in the State of Tennessee, who claims to be place on the Pension list of the United States, came before me and on oath made the following declaration, towit, that he enlisted as a continental soldier in the year 1775 under the Command of Capt Mat. Dewit [sic: Matthew Jouett, company raised in Albemarle County] in the Virginia continental line for two years, in the 7th Virginia continental Reg't. commanded by Colo. McClannegan [sic: Alexandedr McClenachan] That during the said two years he enlisted as a soldier during the War under Capt Carrington, and was transferred to Captain Tarlon Payns [sic: Tarlton Payne's] company and sent to the Southward, that he faithfully served five years & better, that he was taken Prisoner at the fall of Charles Town [Charleston SC, 12 May 1780], that he was prisoner more than twelve months & was exchanged at James Town in Virginia just before the close of the War [see endnote], that he never was discharged, he supposes because the War then closed, he had a permit to go home sick, and that war closed and he never was called on any more. That he is very poor & needy.

In support of the foregoing claim William Lovel and John Foster credible Witnesses came before me and made Oath that they are well acquainted with William Foster before named that he is a very poor man, that he owns nothing but a very small stock of black cattle, no horses, no land, that to their knowledge he owes more than all he is worth, that he is in perfect poverty & needs the aid of Government.

Madrect's[?] Company and in many other situations during the war and under different other captains being several times transfered to different companies during which time he was in actual service better than five years, and the date of his Original declaration was on the — day of — 18— as well as he now recolects and the number of his pension certificate is 16665 And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income whatever and that the whole of my property is set out and described in the schedule hereto annexed marked A amounting in value to Sixty dollars 93\(^4\) cents that he pursues no occupation on account of his inability to pursue any occupation from old age that his family consists of an aged wife three poor Grand children and their widowed mother his daughter and one son about 12 years old William hisXmark Foster

Wilson County } This day Samuel Hogg Senior [pension application S38845] personally appeared before me Edmund Crutcher a justice of the peace for said County, & after being duly sworn according to law deposeth & saith that William Foster the bearer hereof was a Soldier in the Revolutionary War that he belonged to Capt. Tarlton Paynes Company in which I was then a 1st Liet, that we belonged to a detachment of four hundred men under the command of Colo Richard Parker that we marched from Petersburgh [sic: Petersburg] Virginia in 1779 to reinfource the Suthern army he was in the attack on Savannah [siege 24 Sep - 19 Oct 1779] and was made a prisoner at the taking of Charleston by the British in 1780 where he remained untill exchanged an he was a good Soldier and deserved well of his Country Sworn to and Subscribed before me this 28th day of Dec'r 1819

[The following are from bounty-warrant records in the Library of Virginia.]

This is to certify that Wm. Foster a soldier in the 5th Va. Reg't. marched in my Company & Colo. Parker's Battalion to the southward in June 1779 and was not discharged untill July 1781 during which time he only rec'd. one Coat one Waistcoat, one pair shoes & Leather Breeches & two pair of overalls & three shirts

I certify that Wm. Foster has been a soldier for the War, & still continued such in this V. Reg. Art'y.[Artillery] ever since the spring of 1779, previous to which time he was in the Reg't for a term of three years from 1777. [Edward Carrington] Lt Col Arty

[The following are from rejected claims in the Library of Virginia.]

This is to certify that William Foster was a Soldier in my Company upon continental establishment during the Revolutionary War and was Inlisted during the war. He also served in the Southern detachment commanded by Colo Richard Parker, was taken prisoner with us at Charlestown South Carolina and served his time out to the end of the war as a good and Faithful Soldier

Tarlton Payne late Capt. 1st Va Reg't.

I know that William Foster was a soldier in Colo. Richard Parker's Battallion composed of regular continental soldiers in which I acted as Ensign and Paymaster till the close of the campaign of 1779 when I resigned at Augusta in the state of Georgia and that Captain Tarlnton Payne commanded a company in the said Battallion whose Certificate is entitled to full credit

NOTE: Prisoners from Charleston were exchanged at Jamestown in the summer of 1781 before the surrender of Cornwallis at Yorktown on 19 Oct 1781, which was often considered the end of the war.
