[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee Smith County Court August Term 1822

On the 12th day of August 1822 personally appeared in Open Court, being a court of record for the County aforesaid, Britton George, a resident of said County, aged about 80 years who being first duly sworn according to law, doth on his oath make the following statement, in order to obtain the provision made by the Acts of Congress of the 18th March 1818, and 1st May 1820. That he enlisted for one year at the first term under Capt. Hall Dixon [Henry "Hal" Dixon] in the State of North Carolina, Bute County, Bell's old store in the 1st Regt. of North Carolina on Continental Establishment, Commanded by Colonels Clark [Thomas Clark] and Nash [Francis Nash], that he served twelve months and again enlisted for enduring the war under the same Capt. Commanded by the same officers in the same Regt. on Continental establishment - That he continued to serve in the said regiment until the close of the war, when he was discharged from said service at Charlestown [sic, Charleston, South Carolina] by Capt. Hall in the Regt. then Commanded by Col Lytle [Archibald Lytle] and Maj. McRea [?].²

That he was in the Battle of Moore's Bridge in North Carolina [February 27, 1776], Cross Creek, - at the battle of Brunswick, - at the battle at Sullivan's Island [June 28, 1776], at the battle at Germantown [September 11, 1777], - that he was wounded in too [sic, two] places at the battle of Germantown [October 4, 1777], One in the left Knee, and the other in the right thigh - And in pursuance of the act of the 1st May 1820, do solemnly swear that I was a resident Citizen of the United States, on the 18th day of March 1818, and that I have not since that time by gift, sale, or in any manner disposed of my property, or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress, entitled an set to provide for certain persons engaged in the land and Naval Service of the United States in the Revolutionary War passed on the 18th day of March 1818 and that I have not, nor has any person in trust for me, any property or Securities, contracts or debts to me, nor have I any incurred other than what is contained in the schedule hereto annexed, and by me subscribed -to wit, an two year old horse beast - Has a wife name Sally about 60 years of age - has two children living with him, one about 15 years of age, the other about 13 years of age, that he is a farmer by profession, and is now blind, or nearly so.

I Breton George aged Eighty five years do upon oath testify and declare that in the year one thousand seven hundred and seventy seven I enlisted for the term of during the war and served in the first regiment first commanded by Colonel Clark of the North Carolina Line and that I continued in the service aforesaid to the end of the war when I was regularly discharged from the said line and regiment then commanded by Colonel Litle [Lytle] (to wit the first regiment) I further declare that I have never received a warrant for the bounty land promised to me on the part of the United States nor have I ever assigned or transferred my claim in any manner whatever Therefore

Know all men by these presents that I Breton George aforesaid do hereby constitute appoint and ordain the honourable George McDuffie³ to be my true and lawful attorney for me and in my name to ask demand and receive from the Secretary of War of the United States a warrant for the quantity of Land due to me as aforesaid and forward the same to Spartanburg Courthouse South Carolina to the rec'd Hugh Moore.

³ McDUFFIE, George, (father-in-law of Wade Hampton [1818-1902]), a Representative and a Senator from South Carolina; born in Columbia County, Ga., August 10, 1790; attended an old-field school and a private academy; graduated from South Carolina College (now the University of South Carolina) at Columbia in 1813; studied law; admitted to the bar in 1814 and commenced practice in Pendleton, Anderson County, S.C.; member, State house of representatives 1818-1819; elected to the Seventeenth and to the six succeeding Congresses and served from March 4, 1821, until his resignation in 1834; chairman, Committee on Ways and Means (Nineteenth through Twenty-second Congresses); one of the managers appointed by the House of Representatives in 1830 to conduct the impeachment proceedings against James H. Peck; Governor of South Carolina 1834-1836; president of the board of trustees of South Carolina College; elected as a Democrat to the United States Senate to fill the vacancy caused by the resignation of William C. Preston; reelected, and served from December 23, 1842, until August 17, 1846, when he resigned; chairman, Committee on Foreign Relations (Twenty-ninth Congress); died at 'Cherry Hill,' Sumter District (now Sumter County), S.C., March 11, 1851; interment in Cherry Hill Cemetery, Sumter District, S.C.

Litte who hath subscribed the above certificate of Identity both to me well known to be men of respectability and truth and made solemn oath to the truth of the depositions by them respectively subscribed this tenth day of December 1826.

Personally appeared Captain Wm Little [sic] before me and duly made oath that he was well acquainted with Breton or Brittain George throughout the war of the revolution (the within applicant for Bounty Land from the United States the said William Litle [sic] solemnly swear that he was a Captain in the first North Carolina Regiment of Continentals and that at the end of the War the said Regiment was commanded by Colonel Archibald Litle [sic] and this deponent further swears that Brittain George did actually served faithfully to the End of the War and that he (Wm Litle) did deliver said George his discharge after it was officially known of the ratification of peace at Paris in France and that the said discharges was made out for the whole Regiment in June or July 1783 pursuant to an order of Congress and held in reserve by the Commanding Officer of said Regiment until it should be officially made known that peace was ratified for fear the enemy might take some advantage by disbanding the troops. a number of other privates in the said first North Carolina Regiment commanded by Colonel A. Litle there discharges sometime in the fall of 1783 and they well know that report said that peace was made with old England they both swear that they were well acquainted with Brittain before and through the war and they well know that Wm Litle was a Captain as he states.
