# Pension application of Henry Gunter S38778 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

## District of Horry [South Carolina]

On this 31st day of October 1820, personally appeared, in open court, being a court of record for the said district, Henry Gunter aged 69 years, resident in on Little Pee Dee [Pedee River] in said district, who, being first duly sworn, according to law, doth, on his oath, declare that he served in the Revolutionary war as follows: from 1778, when he enlisted under Major Thomas Pinckney for three years, that he was afterwards under Captain Felix Warley nearly four years when he was discharged: that he the said Henry was at the battles of Stono [presumably Stono Ferry, June 20, 1779] Wadboo South Carolina [perhaps the action at Wadboo Bridge July 17, 1781] & at Bladen County North Carolina

And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or other wise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed, and that the said Henry Gunter has not any lands, tenements, Houses, Leasehold Estates or chattels real or personal save the clothing, which are of homespun, which he usually wears.

### South Carolina, Horry District

On this 30th day of October 1821 personally appeared in open court it being a court of Sessions in Common Pleas for the said District Henry Gunter resident of said District aged 70 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the act of Congress of the 18th of March 1818 and the first of May 1820 that he the said Henry Gunter enlisted for the term of 3 years on the \_\_ day of June -- in the year 1779 -- in the State of South Carolina in the company commanded by Captain James Ladson -- in the Regiment commanded by Colonel Charles Cahus Pinkny [sic, Charles Cotesworth Pinckney] in the line of the State of South Carolina -- on the

Continental establishment that he continued to serve in said corps until the 17th of June 1783 when he was discharged from the said service in Charleston in the State of South Carolina.

That he was in the Battle of Stono Wadeboo [Wadboo] in Bladen of North Carolina and that he has no other evidence now in his power of his said service except the affidavits of John Hughs in the Ezekiel Cooper hereunto annexed and in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or other wise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed,

and that the said Henry Gunter has not any lands, tenements, Houses, Lease Hold Estates or Chattels real or personal save the clothes which are of homespun which he usually wears. Sworn to and declared on this 30th day of October 1831
