I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." ## District of West Tennessee

Colonel Robert Hays a citizen of Davidson County in the State of Tennessee came before me and claimed to be placed on the pension list of the United States on account of his services as an Officer in the revolutionary war and after being duly sworn deposeth and saith that he entered the service of the United States as an Ensign under the command of Captain William T. Cole [William Temple Coles] in the 4th North Carolina Regiment commanded by Colonel Thomas Polk, the Brigade was commanded by General Francis Nash continued in said service from the fall of 1776 or Spring of 1777 until the first day of January 1778 when he was transferred to the first North Carolina Regiment commanded by Colonel Thomas Clark to rank as second Lieutenant in said last mentioned Regiment and continued in service until the end of the war. That he is old and very infirm and is in reduced circumstances so much so that he stands in need of aid from Government. That he never has had a pension from the United States or any State Government.
