[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of Tennessee Giles County: Court of Pleas and Quarter Sessions February Term 1826

On this 20th day of February 1826, personally appeared in open court, being a court of record for the County of Giles & State of Tennessee David Hogan, resident in said County, aged seventy years in June next, who being first duly sworn, according to law, doth on his oath make the following declaration in order to obtain the provision made by the acts of Congress of the 18th of March 1818 and the 1st May 1820. That he the said David Hogan enlisted for the term of two years the month & day of the month not recollected, but he believes in the month of April in the year 1776, in the State of North Carolina in the company commanded by Captain Pontenax; commonly called Penter, [possibly Lt./Capt. Philip Prioleau of the Charleston District Regiment of South Carolina militia] in the Regiment commanded by Colonel Robertson (the line not known, but believed to be the North Carolina line), on the Continental establishment. That he continued to serve in the said Corps the expiration of said tour of two years, when he was discharged from said service on Cat Island in South Carolina. That he was in no battles, & that he has no other evidence now in his power.

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

I the said David Hogan am by occupation a farmer; but I am now in consequence of age & infirmity unable to pursue it. The family residing with me is my wife Rebecca, aged about 59

years, who is very infirm, & unable to contribute anything to my support & one son named Wiley aged 14 years 27th of May next, who is a healthy able-bodied boy.

State of Tennessee Giles County: Sct: Court of Pleas & Quarter Sessions August Term 1826 On this 21st day of August 1826, personally appeared in Open Court, being a Court of Record, (& which has the power of fine & imprisonment) for the County & State aforesaid, David Hogan resident in said County, aged seventy years in June last – who being first duly sworn according to law doth on his oath, make the following amended declaration in order to obtain the provision made by the acts of Congress of the 18th of March 1818 and 1st May 1820. That the said David Hogan, enlisted, for the term of two years or 14 months (but he believes 14 months) in the month of April 1776, (the day of the month not recollected) in the State of North Carolina (under one Lieutenant Alston as recruiting officer) and sent on to South Carolina & enrolled in the company of Artillery commanded by Captain Pentenaz, commonly called Punter or Ponteaux) the pronunciation of his name is not well-known – in the Regiment commanded by Colonel Robertson or Colonel Roberts he cannot positively recollect which in the line of the State of South Carolina (as he believes) on the Continental establishment. That he continued to serve in said Corps, until about the 1st day of June 1777 (as he believes) when he was discharged from service on Cat Island in the State of South Carolina. That he hereby Relinquishes every claim whatever to a Pension except the present, that his name is not on the he Roll of any State, except South Carolina – and that the following is the reason why he did not make earlier application for a Pension – which has been owing to his obscure situation in life, for some years past and his ignorance of any provision having been made for Revolutionary Soldiers.
