

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

State of Tennessee Franklin County

On this 17th day of January 1819 before me Jacob C Isaacks the subscriber of the Circuit Judges of said State personally appeared Gideon Hogh of said County aged about sixty-two who being by me first duly sworn according to law doth on his oath make the following declaration in order to obtain the provisions made by the late act of Congress entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" - That he the said Gideon Hogh enlisted in the State of North Carolina Taswell County [Caswell County] in the company commanded first by Captain Pearl and afterwards by Captain Tilman Dixon [Tilghman Dixon] in the Regiment commanded in the first part of his service by Colonel Henry Dixon until his death and afterwards by Colonel John Armstrong of the North Carolina regulars. That he enlisted about 15 months before the Evacuation of Charleston South Carolina by the British in the year 1782 as well as he recollects. That he enlisted for the space of 12 months but was continued in service until after the evacuation of Charleston in 1782 (making about 15 months or upwards) and was sometime after that event discharged in Salisbury North Carolina by said Colonel Armstrong. That he discharged his duty in all the services undertaken or performed by the Regiment to which he belonged in marching, skirmishing and guarding the country etc. though the troops to which he belonged had various skirmishes with the Tories yet he does not recollect of them being in any general engagement during the time. That he has not now his discharge in his possession having left it in the State of North Carolina he left that state about 37 years ago not knowing that it would ever be of any use to him nor does he think it very probable that it is yet in existence – he knows of no other evidence in support of this his case in this State or elsewhere in his power to produce with reasonable exertion in his present situation except what he here produces. He further states that he is in reduced circumstances in life and stands in need of the assistance of his country for support – and he does hereby relinquish all claim to every other pension or claim of emolument granted by any proper Act of Congress or other than that under which this application is made.

State of Tennessee Smith County

This 2nd day of October 1819 came personally before me the undersigned Judge Andrew Hogh who being duly sworn makes oath that he is about 60 years old, that he now resides in the state of Kentucky that he is a brother of Gideon Hogh of Franklin County Tennessee an applicant for a pension now here present – that he has no interest whatever in the application of the said Gideon Hogh for a pension. That they both lived together - this Affiant was not present when said Gideon enlisted but it is well satisfied that he did enlist some time in the year 1781 in the Regiment commanded at that time by Colonel Henry Dixon in the North Carolina line on the Continental Establishment when said Gideon left home for the Army as he understood that this Affiant also enlisted in the same Regiment the year following and when he joined General Greens [Nathanael Greene's] Army near Bacons Bridge South Carolina he saw and was in company with the said Gideon who was then in service and belonged to the same Regiment that they remained together he thinks about 2 months – this Affiant was in the company commanded by Captain Samuel Jones they being in different companies were detached on different services and he did not see him anymore until his time was out as it expired before this affiant's that when this Affiant came home said Gideon was there and had a Discharge signed by Colonel John Armstrong & he believes General Nathaniel Green Armstrong having taken command of the Regiment after the death of Colonel Henry Dixon as he understood.

Gideon Hogh in addition to the facts stated in the declaration heretofore made on the 17th of January 1819 being duly sworn makes oath that the company in which he enlisted and served in as stated in the said Declaration belonged to the Regiment therein stated which was a part of the North Carolina line in the Continental establishment.

I William Hill Secretary of State in & for the State aforesaid do hereby certify that it appears from the musterrolls of the Continental line of this State in the Revolutionary War, that Gideon Hogh a private in Captain Coleman's Company of the 10th Regiment was mustered on the first day of January 1782 for 12 months. His discharges not mentioned.

State of Tennessee Franklin County: On this 6th day of June 1823 personally appeared in open Court being a court of Record for the said County Gideon Hogh aged sixty-eight years resident in the County of Franklin who being first duly sworn according to law doth on his oath declare that he served in the revolutionary war as follows

To wit That he the said Gideon Hogh enlisted for the term of one year on the __ day of August in 1781 in Caswell County in the State of North Carolina in the company commanded by Captain Tilman Dixon of the Regiment commanded by Colonel Henry Dixon in the line of the State of North Carolina on the Continental Establishment that he continued to serve in the said Court or in the service of the United States until the year 1783 when he was discharged from service in Salisbury in the State of North Carolina that the date of his original declaration is of the 17th of January 1819 upon which declaration he has received a pension that number of the pension certificate is 17390.

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed
