[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

District of West Tennessee

John Huggins a citizen of the County of Davidson in the State of Tennessee came before me and claimed to be placed on the Pension list of the United States in consequence of his service for the United States in the revolutionary war and after being duly sworn deposed & said that he enlisted in the service of the United States as a soldier under the command of Captain John Caldwell, in June 1775 and belonged to the 3rd South Carolina Regiment commanded by Lieutenant Colonel James Mason and served three years and was discharged as may be seen by his discharge within enclosed, and served upwards of three years after that in the Militia under General Pickens [Andrew Pickens]. Further states that he is old and very infirm and that from his reduced circumstances he stands in need of aid from Government, that he has never had any pension from the United States or from any State Government.

State of Tennessee Davidson County: On this 23rd day of January 1821 personally appeared and came into Open Court of the Court of Pleas and Quarter Sessions of Davidson County and State aforesaid John Huggins Senior aged eighty one years resident in Davidson County and State aforesaid who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary war as follows in the 3rd Regiment South Carolina line, and that he does not recollect the date of his Original Declaration and that the number of his Pension Certificate is eight thousand nine hundred fifty five. And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed viz.

Amounting in the whole to \$80 and that he is by occupation a farmer and that he is scarcely able to pursue it from Extreme Old Age and the Effects of a wound he received in the left arm while in the Continental Service – that he has in family five persons viz. his wife Polly Huggins aged fifty one years and not healthy, Priscilla Huggins his daughter is fifteen years old and is very healthy and well grown, James Huggins is twelve years old, very healthy and not well grown, Isabella Huggins is two years of age very healthy and well grown




