[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina Williamsburg District: In the Court of Common Pleas

Personally came and appeared before me Langdon Cheves one of the Associate Judges of the Court of Common Pleas for the said State Aaron Odam a native of North Carolina, but now a resident & Citizen of the district & State aforesaid, who being duly sworn deposeth and saith that during the revolutionary war he enlisted in the Continental establishment in the State of North Carolina sometime about the first of June, in the year 1777, under Major Hog [sic, Thomas Hogg], who commanded under General Hogun [James Hogun], who commanded the third Regiment of the North Carolina Continental troops, and were marched to West Point on North River in the State of New York – deponent was from thence marched to Philadelphia where he remained with said troops during the greater part of the winter of 1777 & 1778 from thence they were marched into North Carolina & stationed at Halifax, and there discharged; having at this time served one year. That deponent saith that he then received a regular discharge from the Army signed by Colonel Maiben [sic, probably Robert Mebane], but from the great lapse of time the same has been worn out and destroyed – This deponent further saith that he is about 64 years of age, poor and infirm, and has no means of support only from his own labor, and consequently stands greatly in need of Assistance from his Country & further deponent saith not.

under General Hogun during the Revolution, who being duly sworn doth on his oath declare that he served in the Revolutionary War immediately under Captain Hogg – he further swears, that he was a Resident citizen of the United States on the 18th March 1818 and that he has not since that time by gift, sale or in any manner whatever disposed of his property or any part thereof with intent thereby so to diminish it as to bring himself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that he has not nor has any person in trust for me any property, or securities other than that what is contained in a Schedule annexed marked "A" subscribed by the Pensioner, with an accompanying appraisement signed by William McAllister, Solomon Perritt, and Moses Braby. The Deponent has a wife and grandchild and is 67 years of age and unable to labor.
