Pension application of John Petty S39007 Transcribed by Will Graves f12NC/SC 8/27/09: rev'd 11/22/17

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Tennessee Hawkins County May Sessions 1822

On this 29th day of May 1822 personally appeared in open Court being a Court of Record for said County of Hawkins, John Petty, a citizen of Hawkins County aforesaid aged sixty-four years last March who being first duly sworn according to law doth on his oath make the following declaration is that he served in the revolutionary War in the Regiment commanded by Colonel Sumpter [sic, Thomas Sumter] (afterwards General Sumpter) and enlisted under Nathaniel Risboo [Nathaniel Risbey?] an Ensign belonging to the said Regiment which he inclined to believe was the 1<sup>st</sup> South Carolina Regiment on the Continental Establishment, that his Captain's name was Captain Harry or Henry Risboo [Henry Risbey?]. He enlisted at the first commencement of the war but is not positive in what year 1776 or 1777 but Enlisted for 15 months in South Carolina about 40 or 50 miles from Charleston that he served out his said 15 months & was discharged honorably by Colonel Sumter at a place called Santee that afterwards he thinks some time in 1777 or 1778 he enlisted for 18 months under Captain Hall longing to the first Regiment North Carolina line on the Continental Establishment which Regiment was commanded by Colonel Henry Dixon [Henry "Hal" Dixon] he believes. This declarant served out faithfully his said term of 18 months honorably & received a discharge from Major Hall of said Regiment but is not certain of the time he was discharged his memory being impaired by mental & bodily debility that his said discharges were burnt with his house & everything in it some time ago that his name will be found on the payroll in the Secretary's Office of North Carolina, And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

That I am by occupation a Miller but not able to do much of anything has 3 Children 2 of whom boys one 15 the other 11 years old a daughter about 6 years old a wife aged about 56 years that I am in very indigent circumstances.

On the same day appeared in open Court William Going aged about fifty-six years a Citizen of Hawkins County aforesaid who being also duly sworn states that he is well acquainted with the said John Petty that they served together in the said Regiment viz. the first Regiment commanded by Colonel Dixon that said Petty served out his said Period of 18 months honorably and that he is the Identical John Petty who served in the Revolutionary War and that his aforesaid Declaration he believes is substantially correct, he further states that said John Petty's memory is weak and that he the old man is very frail he believes also that he is in indigent circumstances & stands greatly in need of the aid of his Government this affiant is himself a pensioner of the General Government Revolutionary, that his Certificate is Number 12757 dated 16th May 1819.

State of North Carolina Secretary's Office 4th of October 1822

I William Hill Secretary of State in & for the State aforesaid, do certify that it appears from the musterrolls of the Continental line of this State in the revolutionary War, that John Petty a private in Captain Bailey's [Benjamin Bailey's] company of the 10th Regiment<sup>2</sup> was mustered on the 17th September 1782 for 18 months. Nothing is said of his discharge.

[Veteran was pensioned at the rate of \$8 per month commencing May 29, 1822, as a private for 18 months in the North Carolina Continental line.]
