The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Memorandum That Richard Britt this day appeared in open Court and on his oath stated that he the said Richard was enlisted in the revolutionary war as a Continental Soldier. That he was in service when Charleston was surrendered to the British. That he had served before that surrender upwards of nine months and was taken prisoner & kept as such till Washington's exchange of prisoners which took place in Virginia where he was exchanged -- That he served in the line of South Carolina in the Regiment commanded by Colonel Thompson [sic, William Thomson] and in the company commanded by Captain Baker [Jefferson Baker] and after his capture by Lieutenant Knoff [probably a reference to Lt. John Knapp]. That he enlisted at Orangeburg SC under Lieutenant Colonel James Mayson -- 3 Regiment --

State of South Carolina Camden District} On the 27th day of June in the year of our Lord 1820 personally appeared Richard Britt in Open Court being a Court of record for the aforesaid District aged seventy-seven or eight years resident on Lynches Creek in the District aforesaid who being first duly sworn according to law deposeth that he served three years in the regular service during the revolutionary War in Captain Tolls' [sic, Oliver Towles'] Company of the third Regiment commanded by Colonel Thompson on or about the year of our Lord 1779 he enlisted he thinks under Lieutenant Colonel Joseph Mayson [sic, James Mayson] at that time of said Regiment -- that he made his Original declaration on the 16th day of November in the year of our

Lord 1819 and that his pension Certificate is No. 16127, & the aforesaid declarant doth solemnly swear that he was a resident Citizen of the United States on the 18th day of March 1818 and that he has not since that time by gift, sale or in any manner whatever disposed of his property or any part thereof with intent thereby so to diminish it as to bring himself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that h has not nor has any person in trust for me any property, or securities, contracts or debts due to him nor has he any income other than what is contained in the schedule hereto annexed and by him subscribed he has two sows and seven or eight shoats worth \$10 a disputed claim for 40 acres of land to which he cannot obtain \$30.00, one pot, one oven, one tub & pan worth four dollars amounting not altogether two \$45 (this deponent adds moreover that his wife is the only remaining member of his family who he thinks is older than himself and equally infirm so much so that she cannot make a garment for him that he has hitherto supported himself as well as his decrepit state would admit by the culture of the land & but for the friendly aid of his neighbors would not now be able to support himself.

To the Honorable the Speaker & Members of the House of Representatives of South Carolina The Humble petition of Richard Brit [sic] Sheweth that your Petitioner enlisted in the Continental Army of the United States in the line of South Carolina in a Regiment commanded by Lieutenant James Mayson of the third Regiment, that your petitioner was taken prisoner at the Siege of Charleston [Charleston South Carolina fell to the British on May 12, 1780] & remained

so until the exchange of prisoners by Washington took place in Virginia. That he served in the South Carolina line in a Regiment commanded by Colonel Thompson & in the company commanded by Captain Baker & his enlistment by James Mayson took place at Orangeburg South Carolina. Your petitioner further Sheweth that he never before applied to his country for support because he was able by his labor to provide for himself but he has for a few years past become [word written over and rendered illegible] that he is utterly incapable to do anything for his own Support. Your Petitioner therefore prays your Honorable body to make a provision for his future Subsistence by placing him on the pension list & your petitioner in duty bound will ever pray.

Johnson Elkins being duly Sworn maketh oath that he well knew Richard Brit [sic] during the Revolution war he well knows the Richard Brit served as a Soldier in the American Army of the United States & in the South Carolina line during the Revolutionary war & this deponent believes the said Richard Brit to have [served] at least nine months this deponent further states that the said Richard Brit is very infirm & poor & unable to support himself & is of good character
