Pension application of Robert Cowley S39336 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

South Carolina

Robert Cowley of Chester District in the State aforesaid being Solemnly Sworn Declareth, that in the year 1776 he enlisted as a Common Soldier for fifteen months in the sixth South Carolina Regiment of the Army of the Revolution [under] Colonel Thomas Sumpter [sic, Thomas Sumter], Captain James Duff, that he did duly [serve] with that Regiment until the expiration of his enlistment and was regularly discharged on the first day of June 1777 and that the annexed is a part of his discharge the signature to which has been torn off and lost by accident. The Declarant further states that he is informed and believes that this Regiment was placed by the constituted authorities on the Continental establishment and clothed, paid & subsisted by the United States.

The Declarer further saith that he is a native of the United States that he has always heretofore and still resides therein and that from his reduced circumstances he needs the assistance of his Country for support.

Personally appeared Hugh Knox ¹ Esq. before me James Anderson one of the Justices in and for said District who being duly Sworn agreeable to law affirms and saith upon his oath that he the deponent was an Enlisted Soldier in Captain William Brown's company and sixth Regiment of South Carolina Commanded by Colonel Thomas Sumter and that to his the deponent's certain Knowledge Robert Cowley was a Soldier in Captain James Duff's Company in the sixth Regiment of South Carolina aforesaid from early in the Month of May 1776 until in June 1777 when the Soldiers of said Regiment were discharged, the term of their Enlistment being then fully completed and ended.

the Revolutionary war as follows, viz., In Colonel Sumter's Regiment & in Captain Duff's Company and the date of his original declaration is the 23^{rd} day of September 1819 and the number of his pension Certificate is 14839 and I do Solemnly Swear that I was a resident Citizen of the United States on the 18^{th} day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an Act of Congress entitled an act to provide for certain persons engaged in the land and naval Service of the United States, in the Revolutionary war passed the 18^{th} day of March 1818 and that I have not nor has any person in trust for me any property or securities Contracts or Debts due to me nor have I any Income other than what is contained in the Schedule hereto annexed and by me Subscribed

My Occupation is that of a Farmer I am not able to pursue it will being very old, my family Consists of myself and my wife who is fifty two or three years old, two Sons, one will be twenty one years old on the 14th of next March the other is nine years [old] & four Daughters of age Sufficient to support themselves.

Robert Cowley on the 27th day of October 1826 personally appeared in Open Court, being a Court of Record for the district aforesaid, resident in said District aged Seventy three years, who being first duly sworn, according to Law, doth on his Oath, make the following Declaration, in order to obtain the provision made by the Acts of Congress of the 18th of March 1818, and the 1st May 1820. That he the said Robert Cowley enlisted for the term of 18 months on the 1st January 1776 in the provincial Service in which Service he remained until the declaration of

independence, he was then transferred over to the Continental Service commanded by Captain James Duff in Colonel Thomas Sumter's Regiment (as my discharge in the Office will shew). That he thereby relinquishes every claim whatever to a pension, except the present, that his name is not on the roll of any State except South Carolina, and that the following are the reasons for not making earlier application for a pension.

That he heretofore had a Sufficiency But by being Security to an Administration Bond (as the annexed Certificate of the Ordinary will show) his estate both real & personal has been swept from him, and he is now without any thing for his Support. Save one horse & Cow, a few Hogs, & some little household furniture. That he is a planter by Occupation, & that he is now cripple in one of his wrists, so that he is not able to make a Support, that he has a wife & one child resident with him, his wife is by the name of Mary Cowley, his Son, Thomas I. Cowley, his wife is something like Fifty years old, his Son about 13, his wife is unable to contribute to any degree to their Support, his boy can plough which is not sufficient for the support of the family. And in pursuance of the Act of the 1st May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not, since that time by gift, sale, or in any manner, disposed of my property or any part thereof, with intent thereby to so diminish it as to bring myself within the provisions of an Act of Congress entitled An Act to provide for certain persons engaged in the Land and Naval Service of the United States in the revolutionary War, passed the 18th day of March 1818, and that I have not nor has any person in trust for me, any property or Securities, Contracts or Debts due to me, nor have I any means other than what is contained in the Schedule hereto annexed and by me subscribed. That he had in his possession on the 18th March 1818, one tract of land containing about 250 acres which was sold by the Sheriff of the District of Chester on the first Monday in February 1826, to William Cowley for \$105 of money appropriated to the bond which he was Security to (as the annexed Certificate of the Sheriff will shew) that since the 18th of March 1818, following changes have been made in his property

On this the fourth day of May 1846 personally appeared Robert Cowley a resident of Chester District in the State of South Carolina aged ninety six years who being first duly sworn according to Law doth on his Oath make the following declaration in order to obtain the Benefit of the Provision made by the act of Congress passed the 7th June 1832. That he enlisted in the regular State Troops under Colonel Sumter, Major Henderson & Captain Duff. We were called the sixth Regiment of Rifleman. We done our first duty at Charleston & on Sullivan's Island opposite Charleston, where we fought the Battle of Fort Moultrie then called Fort Sullivan on the 20th of June 1776. We then went to the Cherokee Nation against the Indians & fought the Battle of what was called the half moon or horse shoe, we closed our tour of Eighteen months service in Guarding the Frontiers from the Indians, when I received my regular discharge, which discharge he sent to Washington City when he applied for a pension under the acts of 18th March 1818 & 1st May 1820. He further states that he was promised a portion of Land as a part of his Bounty when he enlisted but he never received any, & he now hopes the proper department will examine his claims and awarded him what is due.


He further states that after the end of his Eighteen Months Enlistment he went into the Militia service as a substitute for David Aiken under Colonel Winn, Major Bonds [?] & Captain Frost & performed a tour of three months duty in the neighborhood of Charleston. After this he was drafted & served a tour of six months duty under the command of Colonel Winn & Captain Turner he rendered this Service in the States of South Carolina & Georgia & in Florida against the Indians. The next Tour of duty he performed as a Substitute for John Gallagher, a Tour of six months under Colonel Brown & Captain Robbins. This service was also rendered mostly in Florida. He was then drafted & sent into service he thinks under Captain Feemster. They went down the Country & Met the Governor & his Guard, who told them that Charleston was taken & they then came home. The balance of his Services was done as a volunteer under General Sumter during which term of Service which lasted twelve months he was in the Battle of Fish Dam on Broad River – in the Battle of Blackstock's & the Battle of Cowpens which took place in January 1781 -- & soon after which his services in ended.

This deponent further states that he is informed that although he draws a pension under the acts of 1818 & 1820 as above stated, he is entitled to an increase of pension under the act of 7 June 1832. That the reason that he did not apply for this increase sooner is that he had no knowledge of his being entitled to it, until informed of it a very short time ago by a friend & Neighbor.

This deponent further says that he is now ninety six years of age or nearly so, that he lives 13 miles from Chester Court House, the nearest place to him where any Court of Record is holden, that by reason of his great age & consequent Bodily infirmity he cannot leave his own home & therefore as the only practicable mode makes this declaration before a Magistrate. That the facts stated are to the best of his Memory which by reason of his great age is liable to err, but he has at least tried to state the truth.




