[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of South Carolina Chester District: Personally appeared William Cockral [sic] of said District and being duly sworn on his oath saith that he was enlisted by Captain David Hopkins in the 3rd Regiment of South Carolina continentals commanded by Colonel William Thompson [William Thomson], that he enlisted sometime in the latter end of the year 1777 & was to serve three years; that he continued in the service in the same company & Regiment (although the company was after Captain Hopkins left the service commanded by Captain John Smith) till the fall of Charleston, where he the deponent was taken prisoner, & put on board a prison ship for about eleven months; and was then sent with other prisoners to the Island of Jamaica where he was kept a prisoner to the end of the war. Was then turned at liberty on the Island to get home as he could, that it was several years before he could get the opportunity of returning. That all the prisoners of his acquaintance died on the Island, except one, a Mr. Esom Franklin who returned sometime after to Chester district & is since dead. That he the Deponent had about six months to serve when the Town fell that he never received but a very small portion of his pay, nor was it possible for him to get a discharge. And that from his reduced circumstances in life, is in need of assistance of his country for support.

Captain John Smith of Fairfield District appeared & being duly sworn on his oath saith that he was well acquainted with the within deponent William Cockral, was with him in the service in the same Regiment, & was both taken prisoners together at the fall of Charleston and was sent on board the same prison ship, *Esk* [*Eske*], together for some time.

State of South Carolina Chester District: In the Court of Equity in on this 14th day of June A.D. 1821 –

Personally appeared in Open Court being a Court of Record for the district and State aforesaid William Cockrill aged sixty-four years on the 13th day of December next resident in said State of South Carolina in District of Chester, who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary War as follows, that he enlisted in the month of March 1777 in the third Regiment South Carolina Continentals commanded by Colonel William Thompson in Captain David Hopkins' Company for three years, and served faithfully until the fall of Charleston he was taken Prisoner and was carried to Jamaica where he remained a prisoner until the close of the war as will more fully appear from the Certificates forwarded to the War Department and that he has received a pension Certificate dated the 5th day of March 1819 and to commence the 16th day of July 1818 and received his pension up to the 4th March 1820.

And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed, and that I am by occupation a farmer and that from old age and the infirmities attendant there on and living on rented land and unable to pursue manual labor so as to sufficiently support myself and wife nor is there any person from whom I can expect any assistance or support, and to consider myself in such indigent circumstances as to be unable to support myself without the aid of my country

South Carolina Chester District: I do hereby certify that while I was Captain in the 3rd Continental Regiment of this State commanded by Colonel William Thompson in support of the Revolutionary war against Great Britain, I enlisted William Cockrell as a private Soldier into said Regiment wherein he served in my company and that to the best of my recollection I enlisted him for three years, and that I do believe that the pay of a private Soldiers in said Regiment was twenty pounds former currency of this State per month, and that the said William

Cockrell faithfully performed his duty in said Regiment until the surrender of Charleston, at which time I believe he was taken prisoner with General Lincoln. Certified under my hand this 23rd of November 1815

To the Honorable the President & Members of the Senate of the State of South Carolina.

The petition of your petitioner humbly Sheweth.

That your petitioner enlisted in the third Regiment of South Carolina for three years under the command of Colonel William Thompson and that he did serve out the term of his enlistment – as a soldier. That he was regularly discharged from said Regiment which will more fully appear by the Muster and payroll entries of John Hague paymaster to the said Regiment and your Petitioner being entirely illiterate and living in a remote part of this State and never knew of any provision made for soldiers until they were barred by the laws of Congress And as your petitioner has never received anything in payment and frequently (of late) hearing that your Honorable House has paid the claims of your old war worn Soldiers therefore submit his claim to your wise consideration praying that you will grant him such compensation as are due for his services. And your petitioner as in duty bound will ever pray.

and made oath that they saw William Cockrill [sic] Senior as a regular enlisted soldier, in the service of the United States, and that they have Just reason to believe, and do believe that he was enlisted in the service aforesaid, as one of the said deponents, John Stone, was then in Camp as a Militia Man; under Colonel John Winn, and that the [sic, they] encamped together, them and the regular soldiers for some time at Purisburg [Purrysburg], and that from causes [?] on fame, or report, he was certainly enlisted in the regular service aforesaid – And it will appear further by the certificate of Colonel David Hopkins, who was Captain in the third Regiment of the South Carolina Troops Commanded by Colonel William Thompson, that he the said David Hopkins was the said Cocrill's [sic] Captain who enlisted him.

State of South Carolina Chester District} Personally appeared William Cockrill [sic] before me the subscribing Justice of Peace for said District, and made oath that he in the Spring of the year, in the year 1775 enlisted as a private Soldier, in the United States service, in Captain David Hopkins' Company, & under said Captain David Hopkins, in the third Regiment of the South Carolina Troops commanded by Colonel William Thompson, and that he continued in said service until the fall of Charleston, & was then and there taken prisoner by the British, and retained as a prisoner on Board of a Man of War Ship, for eleven months and four days, and was then sent as a prisoner of war to Jamaica, and kept there as such, until peace was concluded with Great Britain & the United States of America, and this deponent further saith, that he has never received any compensation for his said services as aforesaid, neither directly, no indirectly, neither by discount, nor otherwise, neither has he assigned his claim to any person, or persons whatever &c

Confiding in the Justice of his Country, he therefore prays your Honorable body to take his case into consideration and grant to him such compensation as are due for his services. And your Petitioner as in duty bound will ever pray
