Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The State of South Carolina

John Crawford of the District of Union and State aforesaid personally came before me and being duly sworn Deposeth. That very early in the Revolution War but at what precise time he can't now recollect he enlisted as a common soldier in the first Continental Regiment of the Georgia line, Colonel McIntosh [Lachlan McIntosh] – Captain Reevs [Reeves?] for the term of one year, during which period the Regiment was generally stationed at Savannah & at the expiration thereof he was regularly discharged which discharge has been lost. That shortly after he again enlisted in the 3rd Continental Regiment of the South Carolina line Colonel William Thompson [William Thomson] Captain Uriah Goodwin in the service of the United States for the period of three years, which time he served as a Musician (Drummer) to the said Regiment, that during this service the operations of the Regiment were principally confined to the seacoast of this State in [sic, and] with it he was engaged in a skirmish with the enemy at Moncks Corner and the Siege of Savannah & that at the expiration of the time of his enlistment he was regularly discharged at Purrysburg on Savannah River – that he afterwards joined the militia of South Carolina under General Colonel Pickens [Andrew Pickens] for a short period – and afterwards enlisted in the Regiment of the North Carolina line commanded by Colonel Lewis [Major Joel Lewis Captain Gordon [Charles Gordon] for one-year which term he also faithfully served and was regularly discharged at the close of the war, so that he was in constant service from the beginning to the end of the War of the Revolution action with the regulars or militia.

The Declarer further saith that he is a native of Durham in England, but emigrated to the United States sometime before the Commencement of the War of the Revolution, and that he has ever since & still continues to reside therein & that from his reduced circumstances he needs the assistance of his country for support.

On this nineteenth day of March 1821 personally appeared in open court, being a court of record for the district aforesaid John Crawford aged sixty-nine years resident near Union Village in the said district who being first duly sworn according to law, doth on his oath declare that he

served in the revolutionary war as follows, that I first enlisted for the time of one-year under Captain Luke McIntosh in a Regiment commanded by Colonel \_\_McIntosh of the Georgia line at the commencement of the raising the said Regiment (which time I do not now remember) and at the expiration of my time was discharged, but has long since lost the certificate thereof, That sometime after I enlisted under Colonel William Thompson who commanded the South Carolina Regiment first called the Regiment of Rangers in the company of Captain Uriah Goodwin for the term of three years, from which service at the expiration of the said term of time I was also discharged and the certificate of which he has also lossed [sic].

And I do also solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed, & further states that by occupation I am a farmer, but old and infirm, and that no person lives with him but his wife an old woman, a daughter named Polly about eighteen years and some months upwards old and a son named William near 16 years old (but of unsound mind) and have no property of any kind or description whatsoever but the following, to wit,

of the Revolution and made oath, that he is intimately acquainted with John Crawford, that at the time this deponent entered into the service of the United States during the revolutionary war in the spring of the year 1778, John Crawford was a soldier in the company commanded by Captain Uriah Goodwin, 3rd Regiment of South Carolina continentals (formerly the Regiment of Rangers) commanded by Colonel William Thompson, that he remained in the service for some considerable length of time upwards of two years and nearly three years that he was honorably discharged from the service at Purrysburg having served out the full term for which he was enlisted. That this deponent knows of his own knowledge that John Crawford discharge all the duties of a good soldier, he having been in several battles within the knowledge of this deponent in South Carolina and Georgia and more [word obliterated and illegible] in the attack and capture of Savannah by the British. I Daniel McDuff<sup>2</sup> late a Lieutenant of the 3rd Regiment of South Carolina Continental line of the Army of the revolution under Colonel William Thompson do hereby certify that John Crawford was attached to the company belonging to that Regiment commanded by Captain Uriah Goodwin and was a drummer as well as I recollect in the years 1776 and 1777 but as to the time Crawford served I do not know, as I was detached from the Regiment, and afterwards made a prisoner of war at Fort McIntosh, And I believe Crawford was regularly enlisted and served that Regiment.
