Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

South Carolina Camden District: In the court of Equity June Term 1818

Johnson Elkins appeared & and on being duly sworn on the Holy Evangelist of Almighty God, deposeth that about the month of June in the year 1777 he enlisted as a private soldier in Captain Uriah Goodwin's Company of the 3rd Regiment of Continental Troops of the State of South Carolina. -- That he continued in service until the month of May 1780 when he was made prisoner at the fall of Charleston [May 12, 1780] where he remained until about the 15th of June following when with several others he effected his Escape. -- The term of his enlistment having expired he subsequently performed several tours of duty with the militia of this State during the revolutionary war. -- That he never could obtain his regular discharge owing as he presumes to the circumstance of his being captured by the Enemy & kept in confinement. -- This deponent further states that from his advanced period of life & from his infirmities, having been wounded at the siege of Savannah [September 16-October 18, 1779] he stands in need of the aid of a pension.
