At a court continued & held for the county of Monroe the 19th day of August 1818.

Isaac Fisher against 65 years the 3d of June last a resident in the county of Monroe aforesaid personally appeared in open court (being a court of record) who being first duly sworn doth on his oath make the following declaration in order to obtain the pension made by the late act of Congress entitled an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war.

That he the said Isaac Fisher enlisted as well as he now recollects about the commencement of the Revolutionary War. That he enlisted for three years in the county now known by the name of Greenbriar, state of Virginia in the company commanded by Captain Mathew Arbuckle and was attached to the 12th Virginia Regiment commanded by Col James Wood. That he continued to serve in said corps until the end of said three years when he was discharged from the service of the United States at a place known by the name of Point Pleasant in the County of Mason Virginia in the year 1773 as well as he now recollects & that his discharge was delivered by himself to Col John Hutchison to obtain for him his land warrant. That he did obtain the said warrant for 100 acres of land & the discharge was left with the officer in Richmond who gave the warrants. That he was in no general engagements, but had several skirmishes with the Indians. That he had the good fortune to kill & scalp one of them. That he is in reduced circumstances & stands in need of the assistance of his country for support & that he has no other evidence in his power except the affidavit of Colo John Hutchison which is hereunto annexed.

The said Court of Monroe County do certify that it appears to their satisfaction not only from the declaration aforesaid but from the affidavit of Col John Hutchison who is a man in whom confidence may be safely placed that the said Isaac Fisher did serve in the Revolutionary War for the term of three years in Continental establishment and from other respectable testimony that he is in reduced circumstances and stands in need of the assistance of his county [p10]

For support. The said court do direct the clerk of this court to transmit the proceeding of testimony had of taken before them to the Secretary of the War department pursuant to the directions of the before mentioned act of Congress.

[p6] At a court of quarter sessions held for the County of Monroe at the Court House on Tuesday the 20th of June 1820 & the 46th year of the Commonwealth. On the 20th day of June 1820 personally appeared in open court being a court of record, Isaac Fisher, aged 57 years, resident in said County who being first duly sworn according to law doth on his oath declare that he served in the revolutionary war as follows: In the 12th regiment commanded by Col James Wood in the company commanded by Capt. Mathew Arbuckle & that he was in the continental line & the date of his original declaration is the 19th day of August 1818 & that he has received a certificate pension numbered 7040 & I do solemnly swear that I was a resident citizen of the United States on the 18th day of March 1818 & that I have not since that time by gift, sale, or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war passed on the 18th day of March 1818 & that I have not nor has any person in trust for me any property, securities, contract or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed to wit:
