The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Be it remembered that on the 3rd day of August A.D. 1818 before me Jonathan H Walker Esquire Judge of the United States for the Western District of Pennsylvania personally appeared John Gunnell a resident of Bedford County and State aforesaid aged fifty-five years & upwards who by me being duly sworn doth on his oath make the following declaration – That in the year 1780 he enlisted in Petersburg Virginia with Captain John Linton in a Regiment of U S Dragoons or Light Horse usually commanded by Lieutenant Colonel Washington [William Washington], was at the Battle of Eutaw Springs [September 8, 1781] &c – the Battle of the Cowpens [January 17, 1781] & sundry skirmishes & at the said Battle of the Cowpens received a wound by a Sabre in the sword arm & hand & also in the head at the said Battle of the Cowpens & served during the War or until its close as a Soldier in said Regiment of Dragoons in the Revolutionary War on the Continental Establishment & at the close of the said War was honorably discharged at Winchester Virginia & that he hath now lost his discharge. That he is now in reduced circumstances with a constitution much impaired & stands in need of the assistance of his country for support & that he hath not now in his possession any further evidence of his said Service he declares on oath as aforesaid & that he has never heretofore received any pension from the United States.

On the 11th day of August A.D. 1821, Before the Honorable Court of Common Pleas now holden in & for said County John Gunnell aged Sixty-three years resident in said County who being first duly sworn according to law doth on his oath declare that he served in the Revolutionary War as follows, that in the year 1780 he enlisted with Ensign Hutchinson in Washington's Corps of Light horse & served in the said Corps of Light horse commanded by Colonel Washington & served in said Corps on the Continental establishment in the Revolutionary War until its close & received during said period of service four severe wounds all which was stated in his original application & declaration on which a pension certificate issued to the said John Gunnell dated the 5th day of August A.D. 1819 No. 13 563 – Signed J C Calhoun Secretary of War, & I the said John Gunnell do swear that I was a resident Citizen of the

United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed Sworn to this 4th of August 1821 in open court
