[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

District of Pennsylvania City & County of Pennsylvania: Sct.

Be it remembered that on this 14<sup>th</sup> day of September A.D. 1818 before me the Subscriber Thomas Armstrong Esq. one of the Associate Judges of the Court of Common Pleas for the County of Philadelphia came James Mathias, aged about Sixty Eight years & upwards, who being by me duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress "Entitled an act to provide for certain persons engaged in the land & naval service of the United States in the revolutionary War." That he the said James Mathias enlisted in Baltimore in the State of Maryland in the Company commanded by Capt. Nathaniel Smith on or about the 3<sup>rd</sup> day of January A.D. 1776 in the provincial troop & continued in said service under Col. Samuel Smith for two years & three months until about the 3<sup>rd</sup> of April A.D. 1778 when he was discharged at Baltimore. That this deponent afterwards on or about the 5<sup>th</sup> day of April A.D. 1779 regularly enlisted in the service of the United States in the Continental establishment in the Maryland Line at Baltimore in the State of Maryland for three years unless sooner discharged by Congress, in the Company commanded by Capt. Edward Oldham in the 4<sup>th</sup> Maryland Regiment of Infantry under Col. Howard [John Eager Howard] (afterwards Gov. of Maryland) that the said James Mathias, honorable [sic] served, during the whole period of the said three years until on or about the 3<sup>rd</sup> day of April A.D. 1781 that at or near Guilford in North Carolina he was regularly discharge from said service on the 3<sup>rd</sup> of April A.D. 1781, that his discharge was signed by Col. Williams [Otho Holland Williams], – that he served for three years at one period in the Continental Service in the war of the revolution in the Maryland Line – that he has lost his discharge & has no evidence in his power except what is hereto annexed. That he was actually engaged in the Battles of Monmouth [June 28, 1778] (New Jersey), at the taking of Stony Point [July 16, 1779] under General Wayne [Anthony Wayne], – at the Battle of the "Cowpens" [January 17, 1781] under General Morgan [Daniel Morgan] & at the Battle of Guilford [March 15, 1781] (North Carolina) – That he hereby releases & relinquishes to the United States & and every claim & demand whatsoever which he has or may have been entitled to for pension money or other Claims & that he is a Native Citizen of the United States & a resident of Delaware County Pennsylvania & by reason of his extreme poverty is in reduced Circumstances in life & stands in need of assistance from his Country for support, being infirm, unable to work & has no property the state or effects whatever except his clothes he has on! - & Prays to be placed on the pension roll at Philadelphia.

[p 5: James Donahoe gave a supporting affidavit in which he states he knows that the veteran served as he states in his declaration and that the veteran is in reduced circumstances and needs the support of his country. Donahoe signed his affidavit with his mark.]


On this 29<sup>th</sup> day of September in the year of our Lord 1819 personally appeared before me the undersigned Chief Judge of Baltimore City Court James Mathias of said City, aged sixtynine years and upwards, who deposeth on oath by me administered That he enlisted at Baltimore aforesaid under Capt. Lansdale, then commanding a recruiting party on or about the 3<sup>rd</sup> April 1778, joined and mustered in Capt. Edward Oldham's Company of the 4<sup>th</sup> Regiment commanded by Col. Jonas C Hall then at Wilmington and in General Smallwood's [William Smallwood's] Division in the Maryland line – that he continued in the same and marched in said Line to South Carolina and was discharged at Deep River in North Carolina on or about the 3<sup>rd</sup> day of April 1781, having served three years in the Line (the period for which he was enlisted in the service of the United States on the Continental establishment): That he was in the battle of Stony Point on the North River then under Capt. Henry Dobson to whose company he was drafted was also under his own Capt. Oldham at the battles of Monmouth in the Jerseys, Cowpens in South Carolina and Guilford Court House in North Carolina. That after having served out his time and obtained his discharge he joined Capt. Landsdale at the siege of York as a volunteer and went into the Fort or Battery commanded by Col. Lamb at the mouth of York River. That having been in the State of Pennsylvania in September 1818 he this deponent was advised to make application from there and went before Judge Armstrong of Philadelphia who took and certified his declaration as an applicant for a pension under the late Act of Congress entitled "an Act to provide for certain persons engaged in the Land and Naval service of the United States in the Revolutionary War". That he hath since been at Philadelphia but could get no information as to the present residence of the person Mr. Bigelow who was his agent on the occasion Neither was he able to obtain any information relative to his application. And being now a resident of the City of Baltimore he respectfully renews his application for a pension being in extreme reduced Circumstances greatly needs the assistance of his Country for support. That in addition to the testimony of James Donohoe in petitioners former declaration he now offers the deposition of Joseph Fisher of the City of Baltimore & also a certificate from the Hon. General Samuel Smith which he prays may be accepted & that his pension may be allowed from the date of Judge Armstrong signature and made payable at the Maryland agency Baltimore

On this 24<sup>th</sup> day of September 1819 personally appeared before me the undersigned Justice of the peace in and for said County Joseph Fisher of the City of Baltimore & State aforesaid Carpenter, a man to me well known as a respectable citizen & credible witness who being by me duly sworn deposeth and saith that he served as a private in Capt. Edward Oldham's company 4<sup>th</sup> Maryland Regiment from 1777 to 1780 – J C Hall commander, that he well remembers James Mathias now present to have been a regularly enlisted soldier in said company on the Continental establishment during the Revolutionary War – and that he is well assured said J. Mathias continued in the service during the time the said Fisher continued therein, and that he is well satisfied he left him in the service when he was discharged and further saith not. deposeth & saith that he was a Lieutenant Colonel in the Maryland line in the War of the Revolution and that upon seeing James Mathias who is an applicant for a pension under the late Act of Congress he is well satisfied that the said Mathias was a soldier in the Maryland line but after a lapse of near forty years he cannot recollect in what Regiment he served. From conversation with the said Mathias who has mentioned so many circumstances with which the deponent was well acquainted and which could not be known by any person who was not present at the times & places referred to, he is fully convinced that the said Mathias was in the Actions at stony point, at the Cowpens and at Guilford Court House and further that all the facts as stated in his deposition are true.

District Court of the United States in and for the Eastern District of Pennsylvania SS

On the 11<sup>th</sup> day of August 1820 personally appeared in District Court of the United States for the District aforesaid (the said Court being a Court of Record having a Clerk, a Seal and keeping a record of its proceedings) James Mathias, aged Sixty-nine years, residing formerly in the County of Delaware but now in Philadelphia, who being first duly sworn in Open Court according to Law on his oath declares that he served in the Revolutionary War as follows viz.

In the 4<sup>th</sup> Maryland Regiment & company commanded by Capt. Edward Oldham – Date of Original Declaration 4<sup>th</sup> of September 1818, Number of Pension Certificate (10.400), and I the said James Mathias do further solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed
