Pension application of James Morriston (Morrison) S40183 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

[Given the similarities of name, place of residence and some similarities between the services described by this veteran and the James Morrison pensioned under FPA S2869, I think it possible that the two pensioners were one and the same man.]

State of Tennessee First Circuit: Hawkins County October 5th 1818

This day personally appeared James Morrison before me Edward Scott one of the Judges of the Circuit aforesaid in State aforesaid and being by me duly Sworn according to law maketh the following declaration (viz.) That he is about Sixty-five years of age a Citizen of Hawkins, and has resided in said County of Hawkins for upwards of twenty [?] years. That he enlisted in the War of the Revolution sometime (as nearly as said affiant recollects) in the Summer of 1777 under Captain Thomas Hutchings of the 5th Regiment Virginia, in Pittsylvania County Virginia for the term of two years, that said Regiment belonged to General Weedens [George Weedon's] Brigade; that this Deponent was marched from thence to Williamsburg where the Regiment remained about two [could be ten] months from thence the us Deponent was marched under the Command of General Weedon to Brandywine in Chester County Pennsylvania in which battle [September 11, 1777] this Deponent was – that after the said Battle this Deponent was marched to Fort Miflin Mills [?] [the Siege of Fort Mifflin or Mud Island Fort, September 26 to November 16, 1777¹] under said General Weeden in the Division commanded by General Greene at the siege of which said Fort this Deponent was from which said place this Deponent was marched to New York from thence to Princetown [Princeton] where a Battle [January 3, 1777] was fought by Washington in which he was victorious and in which battle this Deponent participated but was taken prisoner by the British; having made his Escape from them & joined his Regiment about four weeks thereafter, that this Deponent served his said term of two years honorably & faithfully & was discharged at the Valley Forge by General Weeden, which was an honorable One but which discharge this deponent has not. He states that he gave it to a certain Major William Witcher who stated to this Deponent that if he had his discharge he could get the land he was Entitled to but this Deponent has never received either said land or discharge said Witcher shortly thereafter deceased. He also states that he has no other proof of his said service never received any pension from his Government that he is very infirm and in such indigent Circumstances that he is absolutely stands in need of the assistance of his Country for Support – Sworn to & subscribed the day & date above.

¹ There is no record of the 5th Virginia Regiment being at the Siege of Fort Mifflin. 200 member of the 7th Virginia Regiment under the command of Col. John Green arrived at Fort Mifflin as reinforcements on October 18, 1777.
