Pension application of Peter Pool S40281 Transcribed by Will Graves f21VA 11/2/12

Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." In the Court of Common Pleas of Washington County Pennsylvania No. 178 January Term 1823 Washington County SS

On this 28<sup>th</sup> day of January A.D. 1823 personally appeared in open Court, being a Court Record for said County of Washington, as ordained by the Law of the State of Pennsylvania; Peter Pool a resident of said County & State of Pennsylvania aged between 60 and 70 years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provision made by the acts of Congress of the 18<sup>th</sup> of March 1818 and the 1<sup>st</sup> of May 1820, that he the said Peter Pool enlisted for the term of three years on the 15<sup>th</sup> day of April A.D. 1777 in the State of Virginia, in the company commanded by Captain Thomas Triplett in the Regiment commanded by Colonel William Grayson in the line of the State of Virginia in the 16<sup>th</sup> Regiment and in General Scott's Brigade on the Continental establishment; that he continued to serve in said Corps until the \_\_day of August A.D. 1780 when he was discharged from said service in Fredericksburg in the State of Virginia - That he was in the battles of Brandywine [September 11, 1777], Germantown [October 4, 1777] and Monmouth [June 28, 1778], and several skirmishes, and that he has no other [evidence] of his said services except the evidence of Dennis Pool and Thomas Allison. And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed, and I do declare that I have no tools, except a few farming utensils which I am nearly unable to pursue from age & infirmity that many of my children are married and gone from him and that he has still with him one daughter named Nancy aged 22 vears, who intends leaving him shortly, one son Peter Pool age 23, 10<sup>th</sup> March next, Susannah age 16 years, Sarah aged 12, Elizabeth 10 years; - the 3 last are the only ones that can be considered as it regards the support of an old & infirm man and his wife their mother.

## Fairfax County to wit

On this 17<sup>th</sup> [date written over could be 18<sup>th</sup>] of December 1822 Dennis Pool personally appeared before the subscriber a Justice of the peace for the County aforesaid & made oath that he was present and knows that Peter Pool enlisted for 3 years under Captain Thomas Triplett who commanded a company in the time of the Revolutionary war; that he knows Peter Poll went off

afterwards, and as he has understood and verily believes, did go into the Continental service &c does not know of his said services of his own personal knowledge but from information. Given under my hand and seal the day & year aforesaid

Thomas Allison this day appeared before me aged Justice of the peace for the County aforesaid and made oath, that he knows of Peter Pool's being a Soldier in Captain Thomas Triplett's Company in the Revolutionary war, and he understood that he did so serve and was in the battles of Brandywine & others – Given under my hand & seal this 16<sup>th</sup> day of December 1822 S/ Robt. Ratchliffe

[Facts in file: veteran died August 27, 1829. Except for the children named in the application, no others are named in the file.]

[Veteran was pensioned at the rate of \$8 per month commencing March one, 1823, for service as a private for 3 years in the Virginia Continental line.]
