Pension application of Thomas Randolph S40316 Transcribed by Will Graves f19VA 6/6/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

## Pennsylvania York County:

Personally appeared before me one of the Judges of the Court of common pleas in & for said County Thomas Randolph & on his solemn oath taken according to the law saith that at Stanton in Botetourt County in the State of Virginia on the 14th of January 1775 [he enlisted] under Captain Thomas Posey of the 7th Regiment of the Virginia line & served three years in the Revolutionary War & was honorably discharged as per his discharge within exhibited: that he is more than 71 years of age & is from his reduced circumstances in need of the assistance of his Country for his support he being now at the courthouse of said County of York maintained at the public expense: that he is a citizen of Pennsylvania.

Sworn & subscribed this 7th day of April before me S/ Geo Barnitz S/ Thomas Randolph, X his mark

by made that the facts stated in said petition are satisfactory evidence of the Services performed by said Thomas Randolph as herein stated, and I do hereby certify the same to the Secretary of the Department of War –

## Pennsylvania York County SS

On this first day of August 1820, personally appeared, in open Court, Thomas Randolph – aged 73 years, resident in said County, who being first duly sworn, according to law, doth, on his solemn oath – declare that he served in the Revolutionary war as follows: viz. In the 7th Regiment Virginia line, by Colonel McClellan in the company commanded by Captain Posey [Thomas Posey] – from the year 1775 until 1778, that the date of his original application for a pension is the 17th day of April 1818 – and the number of his pension certificate is 3953 –

And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. Viz.. one table value \$0.50 – two chairs \$0.12 ½ and a few articles of kitchen furniture, value about \$1.50. My occupation is that of a Shoe maker, I cannot perform any labor at it now, on account of blindness. I have no children living with me – I have (that I know of) no friends who are in a situation to afford me any relief or assistance –

[Veteran was pensioned at the rate of \$8 per month commencing April 7th, 1818, for service as a private in the Virginia Continental line.]
