[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Virginia. Judicial Circuit composed of the Counties of Bath, Rockbridge, Augusta, Amherst, Nelson & Albemarle SS

On this 19th day of January 1820, before me, the subscriber, one of the judges of the Superior Courts of law, holden in & for the said Circuit, personally appeared Vincent Tapp aged about sixty-three years, resident in Staunton, in the County of Augusta in the said Circuit, who, being by me first duly sworn, according to law, doth on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in Revolutionary war:" That he enlisted for the term of three years in the latter part of the year 1776, or beginning of 1777, at Wheeling, in the State of Virginia, in the company commanded by Captain Stephen Ashby [a/k/a, Stephen Ashley], of the Regiment commanded by Colonel James Wood, in the land of the State of Virginia, on the Continental Establishment; that he continued to serve in the said Corps, or in the service of the United States, until the Winter of 1779, when he was discharged from service, in or near Morris Town [Morristown], State of New Jersey, that he was in the battles of Brandywine [September 11, 1777] & Monmouth [June 28, 1778]. – That he was wounded in the aforesaid battle of Brandywine – was placed on the pension list by act of Congress (he believes) in the year 1811; that he is now, and has been some years, a cripple, and is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said services – other evidence being filed in the War Department; when was granted a pension: which pension he now relinquishes.

[Facts in file: the veteran was survived by his widow, Susannah Tapp, who died in April 1835; the date and place of their marriage is not shown nor is her age or maiden name given in the file; there is an affidavit dated 1857 in Albemarle County Virginia given Richard Gamble, 87, who testified that he was the brother of the veteran's widow; Gamble also testified that his brother-in-law Vincent Tapp was wounded in the arm at Brandywine and that afterwards the veteran resided in Albemarle County where he taught school for some time in the neighborhood of Charlottesville and then removed to Staunton where he was clerk of the Hastings Court until his

death in March 1824; on June 21, 1824, one Henry I. Tapp was granted letters of administration of the estate of Vincent Tapp, a soldier; in 1832 in Augusta County, one Walter H Tapp stood as security for John Churchman, son-in-law of the veteran; the name of Churchman's wife is not stated in the file; in 1858, the soldier's grandson, Vincent Tapp Geiger was Indian agent in California; his parents are not named. The veteran was initially pensioned under the Special Act of Congress March 3, 1811 at the rate of \$2.50 per month and under the act of April 24, 1816 his pension was increased to \$4 per month.]]

[Veteran was pensioned at the rate of \$8 per month commencing January 19, 1820, for 3 years service as a private in the Virginia Continental line.]

To the Hon.

The Speaker and House of Representatives in General Assembly of the Commonwealth of Virginia

The Petition of Vincent Tapp humbly sheweth.

That your petitioner, twelve or fourteen years ago obtained a Military land Warrant for two hundred Acres, in consequence of his Services as a Sergeant-Major in the 8th Virginia Regiment of the late Continental Army. The said Warrant your petitioner delivered to a certain Capt. George Rice, at the time a Citizen of Frederick County, who friendly promised to have it entered in the proper manner; but a little after Capt. Rice's arrival in Kentucky, he died; Since which your Petitioner cannot find any Account either of the Warrant or entry thereof. Your Petitioner therefore prays a renewal of the Warrant, or such other Act, as will secure to him the benefit of the said Military Land Warrant, as in your wisdom shall think proper; and your Petitioner, as in duty bound shell ever pray &c.

locations in the State of Kentucky & in the Miamis & Sistha & find no location made in the name of Vincent Tapp for two hundred Acres the Quantity received for his Services as a Sergeant Major neither could I hear anything of the Land Warrants. He further deposeth that if he had known that it had been necessary that he would have obtained a Certificate from the said register of the said office, for the same.

Be it remembered that on this 20th day of July 1819 personally appeared in open Court the Subscriber Vincent Tapp aged Seventy Two years & being desirous of availing himself of the provisions of an Act of Congress entitled an Act to provide for certain person[s] who were engaged in the land & naval Service of the United States in the Revolutionary War & after being duly sworn according to law made & subscribed the following declaration with that he the said Vincent Tapp Served true & faithfully in the revolutionary war at what precise time he cannot recollect enlisted into the Continental Service in the County of __ State of Virginia in the 12 Regiment of the Virginia line under Captain Ashly [Stephen Ashby or Ashley] Colonel James Wood Command which Regiment belonged to the brigade [of] General Scott [Charles Scott] & was in the following battle to wit Brandywine [September 11, 1777], Germantown [October 4, 1777] & Monmouth Court house [June 28, 1778] that he was discharged in West Point after having faithfully [been] in Service two years in constant Service which discharge he kept for some time but owing to some casuality [casualty] or accident he lost from which circumstance he has it not in his power now to produce it he also states that he has no other means in his power to prove his Services now except by his own oath that he is now in reduced Circumstances and stands in need of his Country['s] Gracious Assistance for support & has never been placed on any pension list of the United States nor has he ever been without the __ of the same that he now resides in the County of Washington State of Tennessee. Sworn to and subscribed in open Court this day of __ written.
