Pension Application of Peter Barrott S41427 VA Transcribed and annotated by C. Leon Harris. Revised 5 May 2017.

District of North Carolina To Wit

On this 14<sup>th</sup> day of May A.D. 1818 before me the Subscriber Chairman of the court of record for the county of Person, in said District, personally appears Peter Barrott, aged 62 years, Risident in the said county of person, in the aforesaid district, who being first duly sworn, according to law, doth, on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress entitled an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary war: That he the said Peter Barrott enlisted in the State of Virginia, in the company commanded by Captain Marks [possibly Isaiah Marks] of the Eleventh Regiment of the Virginia line, on the continental establishment. That he continued in the said Corps, or in the service of the United States for the Term of three years; at the end of which time he was discharged at Leesburg, in the Sate of Virginia by Col. Febecker [sic: Christian Febiger]. That he was in the Battles of Brandywine [11 Sep 1777], Monmouth [28 Jun 1778], & Stony point [16 Jul 1779], and that he is in reduced circumstances, & stands in need of the assistance of his country for support Peter Barroll

[The following is from a copy in the file, apparently made from an original that was hard to read.] On the 12<sup>th</sup> day of Septem'r. 1820 Personly appeard in Open Court State of No. Carolina } Peter Barret, aged sixty three years, who doth on his Oath make the Person County following declaration, in order to obtain the provission made by the act of Congress of the 18th March 1818 and the 1st May 1820. That he the said Peter Barret, enlisted for the Term — of — onths [sic] in the State of Virgina in the Company commanded by Capt. Markes. the 11th regiment commanded by Colo. Febecker in the line of the State of Virgina Continental establishment, that he continued to serve in said corpes three years, at which time he was discharged at Leesburg Town in the State of Virgina Leuden [sic: Loudoun] County – that he was in the battle at Monmouth the 28th June 1778 & at the battle at Stoney point 17<sup>th</sup> June 1879 [sic] – and in persuit of the act of the 1<sup>st</sup> May 1820 I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "an act to provide for certain person engaged in the land and naval service of the United States in the Revolutionary War" passed on the 18th day of March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the Schedule hereto annexed and by me subscribed.

I am a planter by occupation, my family consits of my self and wife Sarah about 57 years of age, son Jabus[?], 20 years of age, son John 16 years of age a daughter 13 years of age, quit uncertain how long they may remain with me, myself and wife are both unable to work, my wife has been nearly blind for several years I reside in Person County and State of No. Carolina, I have recei'd. three pension, my certificate bares date the 14<sup>th</sup> May 1818, without a number Sworn to in open Court the 12<sup>th</sup> Septem'r. 1820 Peter Barret & sign'd.

[The following are from rejected claims in the Library of Virginia indexed as Barrett, Peter.]

State of North Carolina } Person County }

Personally before me Benj'n W. Milner, one of the acting Justices of the peace in & for the County aforesaid came Peter Barret who being duly sworn, makes the following declaration to enable him to obtain a land Warrant from the State of Virgina, for his servises in the revolutionary war. That he enlisted for a Term of years in the state of Virgina, in the Company Commanded by Capt Markes – the Eleventh regiment commanded by Colo Febecker in the line of the State of Virgina Continatal establishment. That he continued to do duty in said corpes untill discharged at Leesburg Town Lowden County State of Virgina. That he has lost or mislaid his discharge, it being much worn

That he was in the battle of Monmouth on the 28th June 1778 and the battle Stoney Point of the 17th June 1779. That he is now seventy three years of age or thereabout. That He draws a pension from the General Government – which is his dependance for susistance. He further swares that he was promised Land when he enlisted, that he has never drawn a warrant or parted with his claim – or authorised any person to do so

That he now resides in the County of Person, State of North Carolina. That he is in fact the person which he now represents himself to to be subscribed & sworn before me this 27th day of Septem'r AD Peter his Xmark Barrett

Please examine if Jno. Chatham [John Chatham S41475] has rec'd a warrent (Company Capt Thos West Regiment Colo Stephens [Capt. Thomas West, Col. Edward Stevens], served during or to the war discharged at Winchester. He also was comanded by Capt Lamma [sic: Nathan Lamme] Redg't reduced to 6th Duncan Rose
