[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina, Chatham County

On this the 13th day of February 1832 personally appeared in open Court it being a Court of Record for the County aforesaid, Thomas Dickens, resident in said County aged 69 or 70 years who being first duly sworn according to Law; doth on his oath make the following declaration, in order to obtain the provision made by the Acts of Congress of the 18th of March 1818 and the first of May 1820 that he Thomas Jenkins enlisted on the __ day nor Month not recollected in the year 1782 in the State of North Carolina in the Company commanded by Captain Bacotes [Peter Bacot] in the Regiment Commanded by Colonel Little [Archibald Lytle] and the line of the State of North Carolina on the Continental establishment, that he continued to serve in the said Corps until the close of the war when he was discharged from the service in the State of North Carolina, that he hereby relinquishes all Claim whatsoever to a pension except the present, that his name is not on the Roll of any other State except the State of North Carolina and the following are the reasons for not making earlier application for a pension – The reasons for not having made application earlier are for the want of Information how to make a proper application and for the want of some friends to do the business correctly which I was unable to do myself.

And in pursuance of the Act of First of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th of March 1818 and that I have not since that time by gift, sale or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of An Act of Congress entitled "An Act to provide for certain persons engaged in the land and naval Service of the United States in the Revolutionary War," passed on the 18th day of March 1818; and that I have not, nor has any person in trust for me, any property or securities, contracts or debts due to me, nor have I any income other than what is contained in the Schedule hereto annexed and by me Subscribed and that since the 18th of March 1818 no changes have been made of my property.

to walk again – his daughter is able to do her duty and is able to do as much has any person of her age. She is twenty years of age this the 27th day of present month of February.

State of Tennessee, Lincoln County: To all to whom this may come greetings

Know ye that we John H. Taylor at William F. Lang Justices of the peace for the said County of Lincoln and State of Tennessee has caused James Sykes [sic] to appear before us who being first Sworn upon the Holy Evangelist of Almighty God deposeth and saith that he knew Thomas Dickens of the State of North Carolina that he served with him in the war of the Revolution that he was a private in the Company Commanded by Captain Coats [Peter Bacot] in the Regiment Commanded by Colonel Little [sic, Lytle] upon the Continental establishment that he believes the said Dickens enlisted in July in the 1782 or thereabouts, that he served about 12 months and was then discharged upon parole until the close of the war that he recollects it well that they both enlisted at the same time served together and was discharged at the same time – and that he enlisted in the State of North Carolina and was discharged near Charleston in the State of South Carolina and further this deponent saith not.

Sworn to and subscribed before us this 27th day of March A.D. 1832.
