The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of North Carolina

On this 12th day of October 1819, before me, the subscriber, one of the Judges of the Superior Courts of law for the said district, personally appeared Isham Finch aged 58 years, resident in Montgomery County and the said district, who, being by me first duly sworn, according to law, doth, on his oath, make the following declaration, in order to obtain the provision made by the late act of Congress, entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war:" That he, the said Isham Finch enlisted for the term of nine months in Nash [County] in the state of North Carolina in the company commanded by Captain John Baker of the Regiment commanded by Colonel Hogan [James Hogun] in the line of the State of North Carolina on the Continental Establishment; that he continued to serve in said corps, or in the service of the United States, until the month of May 1779, when he was discharged from service in Halifax state of North Carolina that he was in the battles of Guilford [March 15, 1781] afterwards as a militia soldier and that he is in reduced circumstances, and stands in need of the assistance of his country for support; and that he has no other evidence now in his power of his said services.

This day came Jordan Sharod¹ respectable person and made oath that Isom Finch [sic] of Montgomery County served under Captain John Baker, nine months, a soldier in the Revolutionary War, under Colonel Hogun Commander.

On this 10th day of January in the year of our Lord 1822, personally appeared in Open Court being a Court of record, for the said County Isham Finch aged about Sixty-one years, resident in Montgomery County, who being first duly sworn, according to law, doth on his oath declare that he served in the revolutionary war as follows, in the third North Carolina Regiment in the year 1778 under the command of Colonel Hogun, & served nearly one year and was discharged at Halifax County, and the state of North Carolina –And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or otherwise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed
