The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." State of North Carolina, Camden County: Court of Pleas & Order Sessions May Term 1818

On this 6th day of May 1818 before us the subscribers three of the Justices of the Peace of the Court for the said County of Camden, Personally appeared Isaac Gallop aged 58 years resident in the said County of Camden in the State of North Carolina who being by us first duly sworn according to Law, doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress, entitled "An act to provide for certain persons engaged in the Land and Naval Services of the United States in the revolutionary War," that he the said Isaac Gallop enlisted in the said County of Camden in the State of North Carolina in the company commanded by Captain Manlove Tarrant and was turned over to the second Regiment under the command of Colonel John Patten that he continued to serve in the said Corps or in the service of the United States, until the said Isaac Gallop was taken Prisoner by the British at Charleston [May 12, 1780] in the State of South Carolina and that he with some others made their escape from prison that he was in four general engagements or Battles, to wit, at Brandywine [September 11, 1777], Germantown [October 4, 1777], Monmouth [June 28, 1778] & Trenton [December 26, 1776] & most generally the Scouting parties, and that he is in reduced circumstances and stands in need of the assistance of his Country for support and that he has no other evidence now in his power of his said Service.

Personally appeared in open Court John Taylor, who being duly sworn, deposed its, that he was acquainted and it is still acquainted with Isaac Gallop and that he knows of his on knowledge that the said Isaac Gallop was a soldier in the service of the United States and continued in the said service until he was taken a prisoner by the war British & made his escape there from & Isaac Gallop as a soldier did served in the Army nine months & more during the Said War.

one old mare, one young Horse lately bought & not paid for, four old flag-bottom chairs, two axes, two hoes, one plow, two bread Trays, one horse cart, four old barrels, one Small Box, Six pattles, one Iron wedge, one case of knives & forks, one Curry comb, two ticklers, one foot Glass, one tin gunnell, one half gallon basin (pewter),

State of North Carolina, Camden County: District of Edenton Superior [Court] of Law Fall term 1820 On this third day of November 1820, personally appeared in Open Court the same being a Court of record Isaac Gallop aged fifty-nine years who being first Sworn according to law, doth on his oath make the following declaration in order to obtain the provision made by the acts of Congress of the 18th of March 1818 and the 1st of May 1820, that he the said Isaac Gallop enlisted for the term of three years on the day of about the year 1778 in the State of North Carolina in the Company commanded by Captain Tarrant in the Second Regiment Commanded by Colonel Pattern on the line of the State of North Carolina in the Continental establishment: that he continued to Serve in the said Corps until the taking of Charleston when he was made prisoner by the enemy, from whom he escaped and was never afterwards exchanged. That he was in the Battles called at Brandywine & Monmouth & at the Siege of Charleston; and altogether Served his country against the enemy for three years – and in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or otherwise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. And the said declarant, further says that he is a farmer, his age is 59 years, and he is not healthy, his family consists of Polly Gallop aged 32 years, Martin Gallop aged 17 years, and Robert Gallop aged 14 years. Polly is very unhealthy, Martin & Robert are totally healthy – Sworn to and declared on oath in open Court on the 3rd day of November A.D. 1820 before his Honor Willie P. Mangrum Esq. one of the Judges of the Superior Courts of law & Equity in & for the State of North Carolina. S/ Isaac Gallop, F his mark
