Pension application of Major Glanden S41583 Transcribed by Will Graves f19NC 11/15/07 rev'd 8/30/15

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[North Carolina], County of Nash: SS: Court of Pleas & Quarter Sessions

On this day in May 1828 personally appeared in Open Court (it being a Court of Record expressly made so by the Laws of the State) for the County of Nash, Major Glanden resident in said County, aged Sixty two years, who being first duly sworn according to Law, doth on his oath make the following declaration in order to obtain the provision made by the acts of Congress on the 18th March 1818, and the 1st May 1820 that he the said Major Glanden enlisted for the term of three years (as well as he recollects in the Fall of the year 1777 though does not recollect in what month) in the State of North Carolina in the Company commanded by Capt. Abram Shepherd [Abraham Sheppard] in the Regiment Commanded by Colonel___ Shepherd [Abraham Shepperd] in the Line of the State of North Carolina [10th Regiment] on the Continental Establishment. That he together with the Regiment marched directly off from No. Carolina to Head Quarters at the Valley Forge on the Schuylkill [River] where he was reported and placed under other Officers but does not recollect the names of the Captains & Companies to which he was attached except that at the taking of Stony Point [July 16, 1779] he was attached to a company commanded by Captain Craddick [John Craddock, 2nd North Carolina Regiment] and at Battle Monmouth [June 28, 1778]. That although he enlisted for but three years he was retained in service in the Eastern & northern states as well as he now recollects about four years and was then removed he thinks in the year 1781 [sic 1780] to Charleston South Carolina where he continued in service a few months in the Regt. Commanded he thinks by Col. Harvey until the Siege of the city [Charleston South Carolina was surrendered May 12, 1780] when he was taken prisoner by the British from whom at the end of about four months he made his escape, and went home to Beaufort Edgecomb [sic, Edgecombe] County No. Ca. where he remained but a short time when he joined what was called the twelve months men and was marched back into South Carolina and Continued to serve under Capt. Brevard [Alexander Brevard] until the end of the twelve mos. when he together with the whole Regt. were discharged.

That he never obtained a written discharge because he thought it of no consequence & never applied for one. That he hereby relinquishes every claim whatever to a pension except the present; that his name is not on the Roll of any state except North Carolina; and the following are the Reasons for not making earlier application for a pension (Viz.)

He had always understood that the Pension was only intended for such soldiers etc. as had been disabled in the Battles of the Revolutionary war, or by age or Infirmity, were unable by their own labour to maintain themselves, that until within the last 18 months, he had with the little property he owned been by hard labour enabled to procure a scanty living which is now no longer the case.

And in pursuance of the act of 1st May 1820 I do solemnly swear that I was a resident citizen of the United states on the 18th day of March 1818 and that I have not since that time, by gift, sale or in any manner disposed of my property, or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of Congress entitled "An Act to provide for certain persons en-

gaged in the land and naval service of the United States of the Revolutionary War" passed on the 18th day of march 1818. And that I have not nor has any person in trust for me, any property or securities, contracts, or Debts, due to me, nor have I any income, other than what is contained in the schedule hereunto annexed and by me subscribed.

State of No. Ca., Nash County Court May Term 1828

Kinchen Taylor & Jesse H. Drake, Esgrs., J. P. & Jacob Ing were appointed a Committee to Value the Property of Major Glanden & that they returned a List & Schedule thereof into this court.

North Carolina, Nash County No. 1 November 11th A. D. 1826

This day came Captain Micajah Petteway¹ aged Sixty Six years before me Jesse H. Drake one of the Justices of the peace for the County & State aforesaid and after being duly Sworn upon the holy Evangelist of Almighty God to depose the truth the whole truth and nothing else but the truth; Deposeth and saith as follows:

That during the old revolutionary war, he the said Micajah Petteway was personally acquainted with Mr. Major Glandon now a resident of the County and State aforesaid, that he knew the said Major Glandon to be a regular Soldier in the United States Army; That he knew the said Major Glandon to be at the Storming of Stony Point; and that he has every reason to believe that he was at the battle of Monmouth and that he was also taken prisoner by the British at Charleston S. C. And that the said Major Glandon during the revolution war conducted himself with the greatest propriety becoming a Soldier, so far as came to his knowledge. That he believes him to be worthy and legally entitled to a pension, and further this deponent saith not.

North Carolina Nash County No. 2

November 11th day A.D. 1826

This day came Elisha Battle for me Jesse H. Drake one of the Justices of the peace in and for the County and State aforesaid and after being duly Sworn upon the holy Evangelist of Almighty God to depose the truth the whole truth and nothing else but the truth Deposeth and saith as follows: That during the old revolutionary war he the said Elisha Battle was personally acquainted with Mr. Major Glandon now a resident of the County and State aforesaid. That he hired the said Major Glandon as a Substitute for a three months tour in the militia, that at the time he hired him he believed him to be a regular Soldier belonging to the United States Army, that he was taken prisoner by the British at Charleston S. C. and had deserted from them. That the said Major Glandon as a Militia [man] was Stationed at Tarborough N. C. but within a Short time there came on a company of regular Soldiers through Tarborough and the [portion of the text torn from the document] went off with him. That the said Major Glandon ever conducted himself with the greatest propriety becoming a Soldier so far as came to his knowledge, that he believes him to be worthy and legally entitled to a pension and further this deponent saith not.
