Pension application of Joseph Hassell S41602 Transcribed by Will Graves fn17NC 4/24/11

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call errors or omissions to my attention.]

State of North Carolina Tyrrell County

Joseph Hassell of the County State aforesaid being duly sworn deposeth he served as a common soldier in the Revolutionary War under Colonel Selby Harvey from about the 20th of March 1776 until the last of December in the same year and that about the 16th day of April 1781 he enlisted in the Continental service, of the United States & was immediately put in the company of Captain Clement Hall, who belonged to the Regiment of Colonel Hardy Murfree and that he served in the said Continental service from the said 16 April 1781 until about the 21<sup>st</sup> May 1782 as orderly Sergeant of Hall's Company about twelve months & that afterwards till the end of said term he was a common soldier in Captain Benjamin Bailey's company until he was discharged.

He further swore that he is aged about sixty-one years old & that he is infirm & stands in need of the benefit offered in the act of Congress for the relief of the officers and Soldiers of the Revolutionary War for his support & that his discharge has been lost or mislaid.

James Wiley<sup>1</sup> being duly sworn deposeth that the above affiant Joseph Hassell did serve as a Sergeant in the revolutionary War from the 16th of April 1781 until about the 21st May 1782 in the company of Captain Clement Hall for the above 12 months and afterwards in a company of Captain Benjamin Bailey until the time they were discharged – and that he was a soldier with him during the whole time, and he does now well know him; & does now and has ever since lived near him and that he affiant is very poor & infirm & does much need the benefit of the Act





State of North Carolina Tyrrell County: Court of Pleas & Quarter Sessions April Term 1821 The following is a Schedule of the whole Estate & Income of Joseph Hassell of Tyrrell County of North Carolina aged Revolutionary Pensioner of the United States his necessary clothing & bedding excepted viz.

I Joseph Hassell of the County & State aforesaid do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed So help me God
