Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The State of Ohio Sct.

On this 9<sup>th</sup> day of May in the year of our Lord 1818 before me the subscriber President of the Courts of Common Pleas for the 4<sup>th</sup> circuit of said State; personally appeared Jacob Humphreys aged about sixty-nine years a resident of the United States at present residing in the County of Licking and State aforesaid who being by me first duly cautioned and sworn according to law; doth upon his oath make the following Declaration in order to obtain the provision of the late act of Congress entitled "an act to provide for certain Persons engaged in the land and naval service of the United States in the revolutionary war" viz. – That he enlisted at Charleston in the State of Maryland in the spring 1775 as he believes in a Troop of horse commanded by Captain John Rudolph in the 2<sup>nd</sup> Regiment commanded by Colonel Henry Lee [Henry "Light Horse Harry" Lee] in the Continental establishment for the term of three years. that some short time before the expiration of the Term of three years said deponent again enlisted under Captain Rudolph for during the War, that he was in the Battle of Trenton [December 26, 1776], at the taking of the Hessians; that he was at the Battle of the White Plains [October 28, 1776], at the Battle of Monmouth [June 28, 1778] at the battle of Stony Point [July 16, 1779]; at the battle of Powlers hook [Paulus Hook, August 19, 1779] & at the battle of Sandy hook [January 22 – 23, 1776] – that the Army then went into winter quarters at Burlington and in the spring following Deponent marched with the Army to North Carolina where he continued until the surrender of Lord Cornwallis [October 19, 1781] at which place said Deponent received an Honorable discharge in writing signed by Captain Rudolph and Colonel Lee but which said discharge he has long since lost or destroyed; Deponent states that he is old and infirm and in very reduced and needy circumstances; and needs the assistance of his country for support; and that he has no other evidence now in his power of his said services and further saith not.

The State of Ohio Licking County SS

On the 24<sup>th</sup> day of October 1820 personally appeared in open Court of Common Pleas Holden in Newark for the County of Licking being a court of Record, proceeding according to the Course

of the Common Law, with a jurisdiction unlimited in point of amount and keeping a record of its proceedings; Jacob Humphrey aged 72 years; and who being first duly sworn doth on his oath make the following Declaration in order to obtain the Provisions of the acts of Congress of the 18<sup>th</sup> of March 1818 and first of May 1820 – that he served in the Revolutionary War in the company commanded by Captain John Rudolph in the Regiment commanded by Colonel Henry Lee in the line of Virginia and has obtained a pension under the act of Congress of the 18<sup>th</sup> of March 1818, his certificate being numbered 10944. And I do solemnly swear that I was a resident Citizen of the United States on the 18<sup>th</sup> day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18<sup>th</sup> day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed
