¹ BEECHER, Philemon, a Representative from Ohio; born in Kent, Litchfield County, Conn., in 1775; received a classical education; studied law; was admitted to the bar and practiced; moved to Lancaster, Ohio, in 1801 and continued the practice of law; member of the State house of representatives in 1803 and 1805-1807, serving as speaker in 1807; unsuccessful candidate in 1807 for election to the United States Senate, and also as judge of the Ohio Supreme Court; major general in the State militia; elected as a Federalist to the Fifteenth and Sixteenth Congresses (March 4, 1817-March 3, 1821); unsuccessful candidate for reelection in 1820 to the Seventeenth Congress; elected as an Adams-Clay Republican to the Eighteenth Congress, and an Adams candidate to the

{Revolutionary claim,} {Act 18th March, 1818} State of Ohio, Ross County

Court of Common pleas

On this 23rd day of August 1821 personally appeared in open court being a *court* of record for the county and state afforesaid Cornelius Hurley age: 65 and upwards resident in the county of Ross and State aforesaid, who Being first duly sworn according to law, doth on his oath declare that he served in the Revolutionary War as follows, that on or about the 14th February 1776 he enlisted for two years that he served in Captain Phillip Lee's company until the Captain died of wounds received in the battle of Brandywine [September 11, 1777] that he served in said battle and in the battle of York Island [probably a reference to the Battle of Harlem Heights, September 16, 1776], the White plains [October 28, 1776] and Germantown [October 4, 1777] after which he was discharged at White march camp from inability to perform duty, which inability produced by the Camp-Fever producing ulcers in his leg which still remain, which with the infirmities of old age renders himself unable to sustain himself by manual labor. And I do Solemnly Swear that I was a resident citizen of the United States on the March 18, 1818. That I have not since that time by gift grant sale or in any manner disposed of any property or any part thereof, with intent there by so to diminish it to bring myself within the previsions of an act of Congress entitled "an act to provide for certain persons engaged in the Land and Naval service of the United States in the Revolutionary War" passed on the eighteenth day of March in the year One thousand eight hundred and eighteen, and that I have not nor has any person in trust for me any property or security, contract or debts due to me, nor have I any income other that what is contained in the schedule hearto annex and by me subscribed, To with a mare

And colt worth about twenty five dollars. That he was placed on the pension list, the Second day of February 1819 and by certificate No 6520, but for which pension he should be on the *Township*, that he has no family living with him. His wife is dead and his three sons and four daughters are all married and have left him. That he boards himself out where he can live the cheapest, that he has no trade.

I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Ohio Sct.

Be it remembered that on the 29th day of May Anno Domini one thousand and eighteen of the Independence of the United States of America the 42nd and of our State the 16th Personally came before me the subscriber President of the Court of Common Pleas of the Second Circuit – Cornelius Hurley of Ross County State of Ohio who after being duly sworn on the Holy Evangelists of Almighty God deposeth and saith that he is in the sixty third year of his age – that he enlisted in Prince William County Virginia on the 14th day of February seventy six, for two years, in the Company of Captain Philip Lee, third Virginia Regiment Commanded by Colonel

Thomas Marshall, our first march after joining said Company was after Dunmore [John Murray, Lord Dunmore, last Royal Governor of the colony of Virginia] below Williamsburg [probably a reference to the engagement at Gwinn Island, July 8-10, 1776], then heard of house landing at New York which caused our men to push on by land immediately to that place, and had a fight with the British on York island [probably a reference to the Battle of Harlem Heights September 16, 1776] and thence went to the White Plains [October 28, 1776] where there was a smart engagement and a smart chance of men killed of General Smallwood's [William Smallwood's] brigade & Delaware troops, thence crossed the River and halted at Brunswick New Jersey and there he got sick and sent to the Hospital at Philadelphia, on recovery he joined the Army at German Town, and was in the conflicts of Brandywine [September 11, 1777] and German Town [Germantown: October 4, 1777], and in that battle General Nash [Francis Nash] was killed with a cannonball, after said battle, Army encamped at White Marsh, where he remained, then discharged by Colonel Marshall on the certificate of the surgeon about two months before the lapse of his time, and same is lost – by ways unknown to affiant. And that affiant from reduced circumstances, needs the assistance of his Country for support.
