Pension application of Thomas Johns S41707 Transcribed by Will Graves

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

State of Kentucky Sct.

On this 8th day of October 1819 before me the undersigned one of the Circuit Judges for the Commonwealth aforesaid personally appeared Thomas Johns aged seventy-seven years resident in Harrison County in the State aforesaid who being first duly sworn according to law doth make the following statement in order to obtain the provision made by the Act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war." That he enlisted as a private soldier in the Army of the United States in the revolutionary war in March 1776 for the term of two years. That the company in which he enlisted was commanded by Captain Samuel Cabell and composed a part of the 6th Virginia Regiment commanded at that time by Colonel Buckner [Mordecai Buckner] who was afterwards as broke [October 9, 1777] for cowardice. That said Regiment belonged to the Virginia line on the Continental establishment. That he continued to serve in said Regiment until the Colonel was broke then he with a number of others of the same Regiment volunteered to serve in a company commanded by Daniel Morgan but he does not recollect to what Regiment said company belonged or whether it was at that time attached to any Regiment shortly afterwards Captain Cabell's Company to which he belonged joined the Regiment commanded by Colonel Daniel Morgan in which company & Regiment he served until the end of his term of enlistment. That he does not recollect the number of the Regiment commanded by Colonel Morgan but he is satisfied that it belonged to the Virginia line on the Continental establishment. That he was at the battle of Stillwater [September 19, 1777], the battle at Saratoga [battle of the Bemis Heights, September 7, 1777] & at the taking of Burgoyne. That he was regularly discharged near Philadelphia in the State of Pennsylvania by General George Weedon & Colonel Parker in spring 1778 that he has lost his discharge & has no other evidence of his services now in his power except the annexed affidavit of John Kendall. That he is now very infirm and from his reduced circumstances in life and stands in need of assistance from his Country for support. Sworn to & declared before me the day & year aforesaid

Also the said John Kendall came personally before me & made oath that he was well acquainted with the above mentioned Thomas Johns who was a soldier in Colonel Daniel Morgan's Regiment & knows that he started to go to Québec under the command of said Morgan but never saw him since until they both came to Kentucky, and that he has been well acquainted with him ever since

On this 13th day of September 1820 Personally appeared in Open court Thomas Johns said court being a Court of Record for said Circuit and so Declared by the law Establishing the Same said John's aged about 78 years resident in the County of Harrison and Circuit aforesaid who being first duly sworn according to law doth on his Oath declare that he served in the Revolutionary War as follows to wit he Enlisted at Amherst Courthouse State of Virginia on the 4th day of March 1776 for 2 years under Captain Samuel Cabble [sic] attached to the Sixth Virginia Regiment commanded by Colonel Buckner the Virginia line on Continental Establishment that he afterwards served out his whole balance of his term of 2 years under Colonel Morgan and was Discharged in Pennsylvania in March 1778 that during his service he was in the Battles of Stillwater at the taking of Burgoyne, Battle of White Marsh [December 5-8, 1777], Trenton [December 26, 1776] and Princeton [January 3, 1777] he further made oath that his Original Declaration as he believes bears date the 8th day of October 1819 in his certificate is numbered 15698

Schedule

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed. I have no Estate real or Personal except a horse old saddle and bridle worth not more than thirty-five dollars my Occupation is that of a farmer and I am unable to support myself by labor I have no family and am not a housekeeper. Given under my hand this 13th day of September 1820.

[p 14: On June 15, 1824 in Clermont County of Ohio, the veteran gave testimony that he is the same person who formerly belonged to the company of Captain Samuel Cabble in the Regiment of Daniel Morgan; that he has lately removed from his former residence to the state of Ohio where he intends to remain and wishes his pension to be paid in the future in the Ohio agency. He signed this application with his mark.]

[Veteran was pensioned at the rate of \$8 per month commencing October 8th, 1819 for service as a private for 2 years in the Virginia Continental line.]
