Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the Secretary of War of the United States

The petition of William Morgan of the State of North Carolina humbly sheweth that your petitioner in the month of July 1777 enlisted as a private soldier in the North Carolina Continental line, that he was attached to the 10th Regiment and under the immediate command of Captain Harmon Herring -- Lieutenant Roundtree & Ensign Shute, that he served for the whole period of his enlistment viz. 3 years and was discharged at Richmond in the State of Virginia. That he was then attached to the new levies under the command of Captain general Lincoln, was taken prisoner at Charleston South Carolina & remained a prisoner 14 months. Your petitioner further states that he is now nearly 70 years of age & in indigent Circumstances, that he needs the assistance of his Country for his Support & he therefore prays the benefit of the Act of Congress providing for persons in his situation.

I William Hill Secretary of State in & for the State aforesaid, do hereby certify, that it appears from the musterroll of the Continental line of this State in the Revolutionary war, that William Morgan a private in Captain Quinn's Company of the 10th Regiment was mustered the __ day of __ 1779 for 3 years -- neither the length of time he served or date of discharge is mentioned. Given under my hand the date above. S/Wm Hill

District of North Carolina Craven County

On this 15th of March in the year of our Lord 1821 personally appeared in the Court of Pleas and Quarter Sessions for the County aforesaid being a Court of Record proceeding according to the course of the Common Law, keeping a record of its proceedings, having a power to fine and imprison and Jurisdiction unlimited in point of amount, William Morgan, being duly sworn in open court according to law doth on his oath saith that he served in the Revolutionary War as follows viz. in the 10th Regiment commanded by Colonel Mebane, in the Company commanded by Captain Herring -- Captain Taylor -- & others -- as will appear by the original declaration of this declarant dated on the __ day of __ A. D. __. This applicant further saith that he has received a pension of \$8 per month according to Certificate No. 16024 and has received a payment of \$60 part thereof.

And I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed
