Pension application of Francis Newby S41923 Transcribed by Will Graves f19NC rev'd 6/24/17

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

District of North Carolina SS

On this Second day of December 1819, before me the Subscriber, one of the Judges of the United States for the district aforesaid, personally appeared Francis Newby, age Sixty-Five years or thereabout, resident of Perguimans in the said district, who being by me first duly sworn according to law, doth on his oath, make the following declaration in order to obtain the provision made by the late act of Congress entitled, "An act to provide for certain persons engaged in the land & naval service of the United States in the revolutionary war:" That he the said Francis Newby, in the year 1781, & in or about the spring or summer of said year, being one of a class, turned out for said class, & entered the service as a soldier, in Franklin County, in the State of North Carolina, for the term of twelve months, in the Company commanded by Captain Yarborough [Edward Yarborough], of the 10th Regiment, in the North Carolina line, on the Continental establishment; that he continued to serve in said company until the battle of the Eutaw Springs [September 8, 1781], when he was wounded in said battle, & was carried to the hospital in Camden, South Carolina, where he remained until he was discharged, which was in or about the spring of the year 1782 as well as he now recollects, which discharge is lost or destroyed; that he was in the battle of the Eutaw Springs; and that he is in reduced circumstances & stands in need of the assistance of his Country for Support.

Sworn to & declared before me, the day & year first aforesaid.

I Henry Potter District Judge as aforesaid, do certify that it appears to my satisfaction that the said Francis Newby did serve in the revolutionary war, as stated in the preceding declaration, against the common enemy, for the term of nine months, on the Continental establishment; and that he is in reduced circumstances & stands in need of the assistance of his country for support; and I now transmit the proceedings & testimony taken & had before me, to the Secretary for the Department of War, pursuant to the directions of the aforementioned Act of Congress.

District of Edenton

On this 12th day of November 1822 Personally appeared in open Court, being a Court of record for the County of Perquimans, Francis Newby of the said County Aged Sixty-Seven years resident in the said County of Perquimans, who being first duly sworn according to law, doth on his oath declare That he served in the revolutionary war as follows: That he served in the Twelve

months service. That he entered the service on the 29th of March 1781 and that he was wounded in an engagement at the Eutaw Springs – and I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or other wise disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed

My family consists of my wife Aged 45 years my son Jordan Newby 23 years my daughter Charety [sic, Charity?] 26 years who is married and lives to herself – Having no permanent Residence of my own – myself & wife live with my son Jordan Newby who is unmarried and I have no other property but what is contained in the schedule.

Francis Newbe [sic] a private in Captain Yarborough's Company of the 10th Regiment was mustered in 1781 for 12 months and was discharged – on the 25th of February 1782.

This day came before us James Harrison & James J. Hill, two of the Justices of Franklin County State above; the Subscriber Benjamin Morgan² of County & State aforesaid, and made oath that he was personally acquainted with Francis Newby now of Perquimans County before he went into the service, during the Revolutionary War & was in service with him at the battle of Eutaw Springs, where he received a wound in his left leg; and he saw him taken off by one of the Soldiers on his back with his leg very bloody. The said Morgan being a Soldier in the said Battle under the command of General Jethro Sumner of the North Carolina line. I am of an opinion we belonged to the Regiment commanded by Colonel Ashe [Lt. Col. John Baptiste Ashe]. Sworn & subscribed to the 11th of December 1819.

We served under General Jethro Sumner of the North Carolina line. Colonel Ashe commanded the Regiment we belong thereto. Sworn & subscribed the 11th of December 1819.
