Pension application of James Overton (Overnton) S41927 fn21NC Transcribed by Will Graves 10/27/10

District of Edenton NC: SS Camden County Circuit

On the 28th day of April 1819. Me the subscriber one of the Judges of the Superior Courts of North Carolina for the said district personally appeared James Overnton aged 66 years resident in the County of Camden in the said district who being by me first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War."

That he the said James Overnton enlisted for the Term of three years on the __day of October or thereabout in the year of 1779 in the State of North Carolina the company commanded by Captain __ of the Regiment commanded by Colonel Gideon Lamb in the line of the State of North Carolina in the Continental Establishment. That he continued to serve in the said Corps or in the service of the United States until the 25th day of October in the year 1782 when he was discharged from service in Charlestown in the State of South Carolina. That he was in the Battles of Stono near Charleston SC and Siege of Charleston South Carolina and in several skirmishes beside – and that he is in reduced circumstances and stands in need of the assistance of his Country for support and that he has no other evidence now in his power of his said Services except the annexed affidavit & discharge. \(^1\)

North Carolina Camden County: Sct.

On this seventh day of August in the year 1827 personally appeared in open Court, being a Court of record of Pleas and Quarter Sessions, and having common law jurisdiction for said County, having a Clerk and Seal, and power of fine and imprisonment, James Overton resident in said County, aged seventy-two years, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the provision made by the Acts of Congress of the 18th of March 1818 and the 1st of May 1820: that the said James Overton having since the obtaining of his pension Certificate lost his discharge, and having no distinct recollection of the

facts, cannot with certainty particularize the day, month and year in which he enlisted, neither the Captain's name who commanded his company, but from a comparison of circumstances has no hesitation in believing that he enlisted in the month of May in the year 1776 in the company commanded by Captain __and Lieutenant Graves [Francis Graves], but he positively declares that it was in the Regiment commanded by Colonel Gideon Lamb in the line of the State of North Carolina on the Continental establishment; and that he continued to serve in the said Corps until the proclaiming of peace in the year 1783, when he was discharged from the service in Charleston in the State of South Carolina; that he hereby relinquishes every claim whatever to a pension except the present, that his name has been placed on the pension List, that the number of his Pension Certificate is 14270, and that he never before exhibited a Schedule of his property, because some time subsequent to the year 1818 he had in his possession, though subject to some debts then existing against him the little property hereinafter described upon the credit of which and by a Lytle produce from it he was enabled to procure a scanty subsistence until its final exhaustion, and further because before and subsequently to the sale of that property he was wholly ignorant how to proceed to obtain the object of this application, and being unable to reward intelligence and unwilling to request it gratuitously, he continued to defer any application till the feelings of extreme necessity extinguished those of delicacy, and then he applied to the Gentleman whose charitable exertions have already elicited the attention and instructions of the Were Department in his behalf. And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed that since the 18th day of March 1818 the following changes have been made in my property

That I never had any part of the balance appearing in my power in the amount with the said Mason Culpepper stated above, nor any acknowledgment thereof in writing nor in the presence of any witness that I have any recollection of, but that I relied wholly such entries as he should think proper to make on his own books as a sufficient establishment of my claim to said balances, that the said Culpepper died in the month of February in the year 1826 and as I am

informed and believe left his estate insolvent, and [indecipherable word] that he could find no entry of the transaction wherefore believing the whole to be lost, and confirmed in that belief upon inquiry of George Ferebee Administrator of said Culpepper and being informed by him that the said estate is insolvent, and moreover that he could find no entry of the transaction above stated in the books or papers of the said Culpepper, I have never attempted any legal proceedings for the recovery thereof. That I sold the said mare received from said Culpepper to Lazarus Overton for a mare and colt and \$10, and the said cart to said Lazarus for \$20 and that in payment of said \$30 I have received three barrels of corn value six dollars and further that the said Lazarus' other charges against me the amount of which I have not hitherto been able to ascertain, that the last mentioned mare I traded with the aforesaid Mason Culpepper for a cow & yearling calf and five dollars which were paid, and that the said cow and yearling and the colt before mentioned are the same which were sold by Execution as stated above.

This declarant respectfully states that he has been brought up to farming labor, that by reason of his age and very laborious exertions in his early days, and of a fracture received in his head in the Service at the Siege of Charleston, which though not sufficient to prostrate useful energy in the season of youth, yet connected with the natural debility of age wholly incapacitates him from procuring any means of subsistence by [his] own exertions, that he has no family residing with him but a wife and a little daughter four years old, and that he has hitherto from the time of losing his land been prevented from claiming assistance from the public funds of his County only by the private Acts of Friendship and forbearance of his good neighbors, and a hope of ultimately obtaining the pensionary relief sought by this application.
