State of North Carolina Currituck County: County Court of Pleas and Quarter Sessions August Term 1818

Personally appeared in open Court, Isaiah Parr who being duly sworn, Deposeth, that at the breaking out of the war of the revolution, he enlisted in the Continental service for six months, under Captain Blount, as a regular soldier and during this tour of duty that he was in the battle of the Great Bridge – that immediately after the end of this first tour, he enlisted again in the Continental service, under Captain Roger Moore, whose company was attached to Colonel Gideon Lamb's Regiment – that he was appointed a Sergeant in his Company and was in the battles of Trenton, Brandywine and Germantown – that he then received the commission of a Captain in the regular Continental Army and was attached to Colonel Clark's Regiment that he was in the battle of Monmouth and at Stoney-point – that afterwards he was appointed Brigade Major and went to watch upon the coast of his native State and while on that duty, he captured Captain Whaling, who came into Currituck with 3 British or enemy row galleys – that he served his country to the and of the war, and until he was discharged, a period of 5 years & 9 months – that all his papers have been destroyed – and being now aged and infirm he stands in need of the benefit of the act of Congress for the relief of the soldiers of the revolution.

I hereby Certify that it appears from the muster rolls of the Continental Line of this State, that Isaiah Parr enlisted as a Sergeant in said Line for 2 1/2 years on the 24th of December 1776 in Captain Goodman's Company of the 4th Regiment and was discharged on the 10th of November 1778.

[Veteran was pensioned at the rate of \$8 per month commencing August 31st, 1818 4 service as a Sergeant in the North Carolina Continental line. The cover sheet erroneously attributes this veteran service to the New York Continental line and the pension application is indexed under the New York veterans.]
