Pension application of William Paylor S41941 Transcribed by Will Graves f32VA 9/25/12

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading fails to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call errors or omissions to my attention.]

Virginia: At a Court held for the County of Charlotte the 3rd day of January in the year 1831 Personally appeared in open Court, being a Court of Record for the said County William Paylor aged about 73 years who being first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the acts of Congress of the 18th of March 1818 and 1st of May 1820. That the said William Paylor enlisted at Charlotte Court House State of Virginia for the term of three years on the 20th day of October 1777 under the command [of] Lieutenant Holt a recruiting Officer who marched first to Alexandria where he was it inoculated for the Small Pox from thence he marched and joined the Army at Valley-Forge [Valley Forge] in the State of Pennsylvania he was put under the command of Captain Nathan Read whose company belonged to the 14th Virginia Regiment commanded by Colonel Davis [probably William Davies] and afterwards by Colonel Russell [probably William Russell]. He crossed the Delaware [River] into Jersey [New Jersey] and was in the Battle of Monmouth [June 28, 17 78], marched from thence to a place called the White Plains marched from thence to West Point where he was taken sick, after recovered he joined the Army at Middle Brook [Middlebrook] where the Army wintered, marched thence to Philadelphia from thence to Charles-Town [Charleston] in South Carolina, he was in the Battle [Charleston was surrendered Made 12, 1780] at that place and was taken prisoner, he remained a prisoner in the hands of the enemy something like 12 or 14 months when he escaped but was taken by Tories and carried back to the enemy at Charles Town and was by them carried to the West Indies – he remained a prisoner until the conclusion of peace – he has now no other evidence of his service than the affidavits of Joseph Harris and Richard Vernon¹ hereto annexed.

And in pursuance of the act of the first of May 1820, I do solemnly swear that I was a resident Citizen of the United States on the 18th day of March 1818 and that I have not since that time by gift, sale or in any manner whatever disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provision of an act of Congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the revolutionary war" passed on the 18th day of March 1818, and that I have not nor has any person in trust for me any property, or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed S/William Paylor²

This day came before me Archibald D Alexander a Justice of the peace for said County Richard Vernon and made oath that William Paylor joined Captain Nathaniel Reids Company at the Valley Forge and served three years during the Revolutionary War, and he was at the battle of Monmouth and marched from thence to the White Plains &c

I heard my brother Robert Harris³ say that William Paylor and himself served together in

the Regular service of the United States three years in the Revolutionary War, that they were both in the battle at Charleston, South Carolina, and both taken prisoners by the British and they deserted from the and were making their way home to Virginia but were pursued by the Tories and overtaken, Paylor was taken by them and carried back to Charleston and delivered to the British.

Sworn to before me at Rough Creek Church is him November 18 S/ John H Marshall, JP

[f p. 14: On January 8, 1838 in Guilford County North Carolina, the veteran applied for the transfer of his pension benefit to the North Carolina agency saying that he had moved to North Carolina in hope of procuring a better support for himself and his family.

His application was supported by an affidavit given by John W Paylor, whose relationship, if any, to the veteran is not stated.]

[Veteran was pensioned at the rate of \$8 per month commencing January 18, 1831, for service as a private for 3 years in the Virginia Continental line.]

[From bounty land records in the Library of Virginia]

I do Certify that William Paylor enlisted in the 14th Virginia Regiment the 28th of August 1777 served 3 years which time he faithfully served.
